**APPLICANT’S STATEMENT OF THE CASE**

In Case No. 23383, Devon seeks an order (1) establishing a standard 640-acre, more or less, spacing and proration unit comprised of the W/2 of Sections 13 and 24, Township 23 South, Range 31 East, NMPM, Eddy County, New Mexico, and (2) pooling all uncommitted mineral interests in the Wolfcamp formation, designated as an oil pool, underlying said unit. and (2)

pooling all uncommitted mineral interests in the Wolfcamp formation, designated as an oil pool, underlying said unit. Devon proposes and dedicates the unit the **Bora Bora 13-24 Fed Com 621H Well**, the **Bora Bora 13-24 Fed Com 622H Well**, the **Bora Bora 13-24 Fed Com 711H Well**, and the **Bora Bora 13-24 Fed Com 712H Well**, as initial wells, to be drilled to a sufficient depth to test the Wolfcamp formation.

Devon proposes the **Bora Bora 13-24 Fed Com 621H Well**, an oil well, to be horizontally drilled from a surface location in the NW/4 NW/4 (Unit D) of Section 13 to a bottom hole location in the SW/4 SW/4 (Unit M) of Section 24.

Devon proposes the **Bora Bora 13-24 Fed Com 622H Well**, an oil well, to be horizontally drilled from a surface location in the NE/4 NW/4 (Unit C) of Section 13 to a bottom hole location in the SE/4 SW/4 (Unit N) of Section 24. The **Bora Bora 13-24 Fed Com 622H Well** is the proximity well, positioned so the unit can include proximity tracts located within 330 feet of the well's completed interval, thereby incorporating the W/2 W/2 of Sections 13 and 24, in order to establish the larger unit covering the W/2 of said Sections.

Devon proposes the **Bora Bora 13-24 Fed Com 711H Well**, an oil well, to be horizontally drilled from a surface location in the NW/4 NW/4 (Unit D) of Section 13 to a bottom hole location in the SW/4 SW/4 (Unit M) of Section 24.

Devon proposes the **Bora Bora 13-24 Fed Com 712H Well**, an oil well, to be horizontally drilled from a surface location in the NE/4 NW/4 (Unit C) of Section 13 to a bottom hole location in the SE/4 SW/4 (Unit N) of Section 24.

The proposed wells are orthodox in their location, and the take points and completed intervals comply with setback requirements for the unit under the statewide rules.
