STATEMENT OF THE CASE

In **Case No. 23387**, Applicant applies for an order pooling all uncommitted interests in the Bone Spring Formation underlying a 322.73-acre, more or less, standard horizontal spacing unit comprised of Lot 1, NE/4 NW/4, and N/2 NE/4 (N/2 N/2 equivalent) of irregular Section 7 and the N/2 N/2 of Section 8, Township 20 South, Range 28 East, Eddy County, New Mexico. The spacing unit will be dedicated to the **Wallaby 7 Fed Com 121H** and **Wallaby 7 Fed Com 131H** wells, which will be horizontally drilled from a surface hole location in Lot 2 of Section 7 to a bottom hole location in the NE/4 NE/4 (Unit A) of Section 8.

In **Case No. 23388**, Applicant applies for an order pooling all uncommitted interests in the Bone Spring Formation underlying a 322.67-acre, more or less, standard horizontal spacing unit

comprised of Lot 2, SE/4 NW/4, and S/2 NE/4 (S/2 N/2 equivalent) of irregular Section 7 and the S/2 N/2 of Section 8, Township 20 South, Range 28 East, Eddy County, New Mexico. The spacing unit will be dedicated to the **Wallaby 7 Fed Com 122H** and **Wallaby 7 Fed Com 132H** wells, which will be horizontally drilled from a surface hole location in Lot 2 of Section 7 to a bottom hole location in the SE/4 NE/4 (Unit H) of Section 8.

In **Case No. 23389**, Applicant applies for an order pooling all uncommitted interests in the Wolfcamp Formation underlying a 322.67-acre, more or less, standard horizontal spacing unit comprised of Lot 2, SE/4 NW/4, and S/2 NE/4 (S/2 N/2 equivalent) of irregular Section 7 and the S/2 N/2 of Section 8, Township 20 South, Range 28 East, Eddy County, New Mexico. The spacing unit will be dedicated to the **Wallaby 7 Fed Com 201H**, which will be horizontally drilled from a surface hole location in Lot 2 of Section 7 to a bottom hole location in the SE/4 NE/4 (Unit H) of Section 8.

The completed intervals of the Wallaby 7 Fed Com wells will be orthodox. Also to be considered in each case will be the cost of drilling and completing the wells and the allocation of the costs, the designation of Applicant as the operator of the wells, and a 200% charge for the risk involved in drilling and completing the wells.

The Wallaby 7 Fed Com wells are located approximately 12 miles northeast of Carlsbad, New Mexico.
