STATEMENT OF THE CASE

In **Case No. 23391**, COG applies for an order pooling all uncommitted interests in the WC-023 G-09 S243532M pool underlying a 160-acre, more or less, standard horizontal spacing unit comprised of the W/2 E/2 of Section 8, Township 25 South, Range 35 East, Lea County, New Mexico. The spacing unit will be dedicated to the **Deerstalker Federal Com #601H** well, to be horizontally drilled from a surface hole location in the SW/4 SE/4 (Unit O) of Section 8 to a bottom hole location in the NW/4 NE/4 (Unit B) of Section 8.

In **Case No. 23392**, COG applies for an order pooling all uncommitted interests in the WC-023 G-09 S243532M pool underlying a 400.82-acre, more or less, standard horizontal spacing unit comprised of the E/2 SE/4 of Section 32, Township 24 South, Range 35 East, Lot 1, SE/4 NE/4, and E/2 SE/4 of irregular Section 5, Township 25 South, Range 35 East, and the E/2 E/2 of Section 8, Township 25 South, Range 35 East, Lea County, New Mexico. The spacing unit will be dedicated to the **Deerstalker Federal Com #701H** well, to be horizontally drilled from a surface hole location in the SW/4 SE/4 (Unit O) of Section 8, Township 25 South, Range 35 East, to a bottom hole location in the NE/4 SE/4 (Unit I) of Section 32, Township 24 South, Range 35 East.

The completed intervals of the Deerstalker Federal Com wells will be orthodox. Also to be considered in each case will be the cost of drilling and completing the wells and the allocation of the costs, the designation of Applicant as the operator of the wells, and a 200% charge for the risk involved in drilling and completing the wells.

The Deerstalker Federal Com wells are located approximately 11 miles west of Jal, New Mexico.
