SELF-AFFIRMED STATEMENT OF JUSTIN TELTSCHIK

1. My name is Justin Teltschik. I am the co-managing partner of Pecos Oil & Gas, LLC. I am familiar with the application filed in this case and have personal knowledge of the information provided in this self-affirmed statement.

2. Pecos Oil & Gas, LLC is a foreign limited liability company registered in Delaware with a principal place of business at 1455 West Loop South, Suite 230, Houston, Texas. It is registered to do business in New Mexico through the New Mexico Secretary of State and is in good standing.

3. Pecos Oil & Gas, LLC is a working interest owner in each of the tracts that comprise the proposed horizontal spacing unit in this case. As a working interest owner, Pecos Oil & Gas, LLC has a right to drill wells in the subject acreage.

4. However, Pecos Oil & Gas, LLC is not an operator of oil and gas wells or other oil and gas facilities in New Mexico. Therefore, it does not have an OGRID number and is not a bonded or registered operator through the New Mexico Oil Conservation Division.

5. Pecos Oil & Gas, LLC has therefore contracted with Redwood Operating LLC to operate wells, operate Pecos Oil & Gas, LLC's working interests, and generally act on behalf of Pecos Oil & Gas, LLC to manage its leasehold interests in New Mexico.

6. Redwood Operating LLC is a domestic limited liability company with a principal place of business at 11344 Lovington Highway, Artesia, New Mexico.

7. As part of its contractual agreement with Redwood Operating LLC, Pecos Oil & Gas, LLC authorized Redwood Operating LLC to manage Pecos Oil & Gas, LLC's leasehold interests that are the subject of this case.

8. Accordingly, Redwood Operating LLC has a right to drill and operate wells on the subject acreage on behalf of Pecos Oil & Gas, LLC.
