
**SUPPLEMENTAL SELF-AFFIRMED
STATEMENT OF GIANNA ROMERO**

1. I am a Senior Land Negotiator for COG Operating LLC (“COG”). I previously submitted self-affirmed statements in these matters.

2. At the March 2, 2023 hearing, the Division requested that COG provide additional information regarding its development plans for the S/2 SW/4 of Section 8, Township 26 South, Range 29 East, Eddy County, New Mexico, which is not included in COG’s proposed spacing units for the Hambone Federal Com #505H and #506H Wells.

3. This acreage is not included in the proposed spacing units for the Hambone Federal Com #505H and #506H wells because it will be included in COG’s spacing units for the Riverwalk Fed Com 503H and 903H wells, which will encompass the W/2 Section of 20, W/2 of Section 17, and the S/2 SW/4 of Section 8, Township 26 South, Range 29 East, Eddy County, New Mexico. Thus, the S/2 SW/4 of Section 8 will not be stranded.

4. I understand this Self-Affirmed Statement will be used as written testimony in the subject cases. I affirm that my testimony above is true and correct and is made under penalty of perjury under the laws of the State of New Mexico.
