In Case No. 23379, Cimarex seeks an order from the Division for the limited purpose of amending Order No. R-22198 to allow for a one-year extension of time to commence drilling the initial well under Order No. R-22198. Order No. R-22198 pooled uncommitted interest owners

in a 640-acre, more or less, spacing and proration unit comprised of the W/2 of Sections 11 and 14, Township 25 South, Range 28 East, NMPM, Eddy County, New Mexico.

Under the original Order, Cimarex would be required to commence drilling by July 25, 2023; and therefore, asks for the deadline to commence drilling be extended for a year, to July 25, 2024, thereby, affording Cimarex the opportunity to continue its development of the unit without interruption.
