Also to be considered will be the cost of drilling and completing said wells, the allocation of these costs as well as the actual operating costs and charges for supervision,

designation of Marathon as operator of the wells, and a 200% charge for risk involved in drilling said wells. Said area is located approximately 14.5 miles Southwest of Jal, New Mexico.
