1. Matador Production Company (OGRID No. 228937) is the designated operator under Order R-21811 entered in Case No. 22052 on August 26, 2021.

2. Order R-21811 pooled uncommitted mineral interests in the Bone Spring formation [Malaga; Bone Spring Pool (42780)] underlying a standard 320-acre horizontal spacing unit comprised of the N/2 N/2 of Sections 14 and 15, Township 24 South, Range 28 East, NMPM, Eddy County, New Mexico.

3. AFFIDAVIT OF HANNA BOLLENBACH

Hanna Bollenbach, of lawful age and being first duly sworn, states the following:

1. My name is Hanna Bollenbach and I am employed by MRC Energy Company, an affiliate of Matador Production Company ("Matador"), as a Senior Landman.
2. I have previously testified before the New Mexico Oil Conservation Division as an expert witness in petroleum land matters. My credentials as a petroleum landman have been accepted by the Division and made a matter of public record.
3. I am familiar with the applications filed by MRC Permian Company ("MRC") in these consolidated cases and the status of the lands in the subject area.
4. In **Case No. 23456**, MRC seeks to re-open Case No. 22052 and add additional parties to be pooled under NMOCD Order No. 21811, which created a standard horizontal spacing unit in the Bone Spring formation comprised of the N/2 N/2 of Sections 14 and 15, Township 24 South, Range 28 East, NMPM, Eddy County, New Mexico. The spacing unit was initially

dedicated to the proposed **Bubba Burton Com #111H and Bubba Burton Com #121H wells**, both with a first take point in the NE/4 NE/4 (Unit A) of Section 14 and a last take point in the NW/4 NW/4 (Unit D) of Section 15.

5. In **Case No. 23457**, MRC seeks to re-open Case No. 22053 and add additional parties to be pooled under NMOCD Order No. 21812, which created a standard horizontal spacing unit in the Bone Spring formation comprised of the S/2 N/2 of Sections 14 and 15, Township 24 South, Range 28 East, NMPM, Eddy County, New Mexico. The spacing unit was initially dedicated to the proposed **Ken Wilson Com #112H and Ken Wilson Com #122H wells**, both with a first take point in the SE/4 NE/4 (Unit H) of Section 14 and a last take point in the SW/4 NW/4 (Unit E) of Section 15.

6. Since the original pooling cases, Matador has received updated title information for these units. After review of the updated title and prior pooling proceedings, we identified additional working interest and unleased mineral interest parties to be pooled, as described below.

7. **Matador Exhibit B-1** contains a Form C-102 for each of the initial wells in these standard horizontal spacing units. These forms demonstrate that the completed interval for the wells meet the standard setback requirements for horizontal oil wells.

8. These wells have been placed in the Malaga; Bone Spring [42780] pool.

9. There are no depth severances within the Bone Spring formation underlying this acreage.

10. **Matador Exhibit B-2** contains a tract map identifying the tracts in each respective unit that contain working interest and unleased mineral interest owners that MRC is seeking to pool in these cases. Both spacing units are comprised of entirely fee acreage. The acreage that is

not highlighted on Exhibit C-2 within these spacing units is acreage that is either: (i) entirely owned by MRC, (ii) the interest owner has signed Matador's JOA, or (iii) has already been force pooled in the original cases for these spacing units. As shown in Matador Exhibit B-2, these units contain a number of very small fee tracts. There were a few tracts for which we identified owners to be pooled which are not shown on this map because they were not identifiable in Matador's Eddy County parcels dataset; however, their interest is listed in Exhibit B-3 as a party MRC is seeking to pool.

11. **Matador Exhibit B-3** identifies the additional working interest and unleased mineral interest owners that Matador is seeking to pool in these horizontal spacing units.

12. **Matador Exhibit B-4** identifies the overriding royalty owners and non-participating royalty interest owners that MRC seeks to pool in each case.

13. **Matador Exhibit B-5** contains a sample of the well proposal letter and AFE sent to the working interest and unleased mineral interest owners MRC is seeking to pool. The costs reflected in the AFE are consistent with what other operators have incurred for drilling similar horizontal wells in the area in these formations.

14. Matador has conducted a diligent search of the public records in the county where the property is located and conducted computer searches in an attempt to locate contact information for each of these working interest and unleased mineral interest owners. Despite these efforts, Matador has thus far been unable to locate many of these additional parties we seek to pool. For a number of these owners, the original proposals were returned as undeliverable. We then conducted additional online searches and attempted to mail the proposals to other addresses potentially associated with those owners that we were able to locate. For those owners where the original proposals were delivered but we never heard a response, we also sent an additional follow-up

letter, a copy of the forms of which are attached as **Matador Exhibit B-6**. These lands involve numerous small tracts that include hundreds of owners showing in our title. Matador was able to locate many of these owners and obtain leases or other voluntary agreements. However, because we have not been able to locate and/or reach agreement with the owners listed in Matador Exhibit C-3 we are proceeding with adding those additional parties to the prior force pooling orders.

15. **Matador Exhibit B-7** contains a general summary of the contacts with the uncommitted working interest and unleased mineral interest owners that Matador is seeking to pool. The chart in **Matador Exhibit B-7** shows the following:

- a. When our proposal was shown as delivered to the owner, a checkmark is shown in the "Delivered to Initial Address." When the proposal was delivered, if we did not receive an election back from the owner or otherwise contact the owner, we mailed a follow-up letter, which is shown as a checkmark in the "Follow-Up Letter Sent" column.
- b. If our original proposal was not delivered, this is shown as a checkmark in the "Unable to Deliver" column. For those undelivered proposals, if we were able to locate a potential alternative address, we sent a proposal to the second address. However, if we were unable to locate a potential additional address, we tried resending the proposal to the address we had originally located. These second proposal attempts are shown as a checkmark in the "Second Attempt" column.
- c. As shown in **Matador Exhibit B-7**, there were a few owners that were entirely unlocatable based on our search.

16. In my opinion, Matador has undertaken good faith efforts to reach an agreement with the uncommitted mineral owners.

17. Matador requests that the overhead and administrative costs for drilling and producing the proposed wells be set at \$8,000 per month while drilling and \$800 per month while producing. These costs are consistent with what other operators are charging in this area for similar wells.

18. Matador has provided its outside counsel, Holland and Hart, with the names and addresses (where available) of the parties that Matador seeks to pool and instructed that they be notified of this hearing.

19. **Matador Exhibits B-1 through B-7** were either prepared by me or compiled under my direction and supervision.
