STATEMENT OF THE CASE

Applicant seeks an order pooling all uncommitted interests within the Yeso formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the N/2 of Section 10, Township 19 South, Range 25 East, Eddy County, New Mexico. The spacing unit will be dedicated to the following wells (collectively “Wells”):

- **Patrick Federal Com 1H, Patrick Federal Com 10H, and Patrick Federal Com 50H**, which will be horizontally drilled from a surface location in the SW/4 NW/4

(Unit E) of Section 11 to a bottom hole location in the SW/4 NW/4 (Unit E) of Section 10; and

- **Patrick Federal Com 11H, Patrick Federal Com 51H, and Patrick Federal Com 71H**, which will be horizontally drilled from a surface location in the NW/4 NW/4 (Unit D) of Section 11 to a bottom hole location in the NW/4 NW/4 (Unit D) of Section 10.

The completed intervals of the Wells will be orthodox. The completed interval of the Patrick Federal Com 1H well will be within 330' of the line separating the N/2 N/2 and S/2 N/2 of Section 10 to allow for the formation of a standard 320-acre standard horizontal spacing unit.

Also to be considered in each case will be the cost of drilling and completing the Wells and the allocation of the costs, the designation of Applicant as the operator of the Unit and the Wells, and a 200% charge for the risk involved in drilling and completing the Wells.

The Wells are located approximately two miles southwest of Artesia, New Mexico.
