BTA Oil Producers, LLC ("BTA") requests that the Oil Conservation Division ("Division") issue an amended Pre-Hearing Order that sets these matters for a contested hearing on July 6, 2023. In support of this Motion, BTA states the following.

1. These cases are currently set for a contested hearing on June 1, 2023 pursuant to the Second Amended Pre-Hearing Order issued on May 11, 2023.
2. The Parties agree that it would be beneficial to have additional time to reach an agreement. Accordingly, BTA requests that the Division issue an amended Pre-Hearing Order setting these competing applications for a contested hearing on July 6, 2023.
3. Counsel for Texas Standard Operating NM LLC and MorningStar Operating LLC do not oppose this Motion.
4. The Parties will file separate continuance motions for their respective cases.
