**STATEMENT OF THE CASE**

In **Case No. 23534**, Permian seeks an order pooling all uncommitted interests in the Bone Spring formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the W/2 W/2 of Sections 21 and 28, Township 22 South, Range 35 East, Lea County, New Mexico (“Unit”). The Unit will be dedicated to the **Bridge State Unit 28 #506H** well (“Well”), to be drilled from a surface hole location in the SE/4 SW/4 (Unit N) of Section 28 to a bottom hole

location in the NW/4 NW/4 (Unit D) of Section 21. The completed interval of the Well will be orthodox.

In **Case No. 23535**, Permian seeks an order pooling all uncommitted interests in the Bone Spring formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the E/2 W/2 of Sections 21 and 28, Township 22 South, Range 35 East, Lea County, New Mexico ("Unit"). The Unit will be dedicated to the **Bridge State Unit 28 #507H** well ("Well"), to be drilled from a surface hole location in the SE/4 SW/4 (Unit N) of Section 28 to a bottom hole location in the NE/4 NW/4 (Unit C) of Section 21.

The Bridge State Unit wells are located approximately 13.8 miles southwest of Eunice, New Mexico.
