STATEMENT OF THE CASE

In **Case No. 23576**, Mewbourne seeks an order pooling additional uncommitted interests under the terms of Order No. R-22067, which was entered by the Division on March 9, 2022, in Case No. 22366. Order No. R-22067 pooled all uncommitted interests in the Bone Spring formation underlying a standard horizontal spacing unit comprised of the E/2 W/2 of Section 11 and the E/2 SW/4 of Section 2, Township 18 South, Range 32 East, Lea County, New Mexico. The Order further dedicated the unit to the Dragonstone 11/2 B2NK Fed Com #1 well and designated Mewbourne as operator of the unit and well.

In **Case No. 23579**, Mewbourne seeks an order pooling additional uncommitted interests under the terms of Order No. R-22069, which was entered by the Division on March 9, 2022, in Case No. 22368. Order No. R-22069 pooled all uncommitted interests in the Bone Spring formation underlying a standard horizontal spacing unit comprised of the W/2 E/2 of Section 11 and the W/2 SE/4 of Section 2, Township 18 South, Range 32 East, Lea County, New Mexico. The Order further dedicated the unit to the Dragonstone 11/2 B2OJ Fed Com #1 well and designated Mewbourne as operator of the unit and well.

Since Order Nos. R-22067 and R-22069 were entered, Mewbourne has identified additional interests in the unit that should be pooled under the terms of the Orders.
