STATEMENT OF THE CASE

MR NM applies for an order pooling all uncommitted interests the Abo formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the N/2 S/2 of Sections 35 and 36, Township 16 South, Range 27 East, Eddy County, New Mexico ("Unit"). The Unit will be dedicated to the proposed Buckskin Federal Com 2H well ("Well"), to be drilled from a surface hole location in the NW/4 SW/4 (Unit L) of Section 35 to a bottom hole location in the NE/4 SE/4 (Unit I) of Section 36.
