**SELF-AFFIRMED STATEMENT
OF BRAD DUNN**

1. I am a landman for Mewbourne Oil Company (“Mewbourne”). I am over 18 years of age, have personal knowledge of the matters addressed herein and am competent to provide this Self-Affirmed Statement. I have previously testified before the New Mexico Oil Conservation Division (“Division”) and my credentials as an expert in petroleum land matters were accepted and made a matter of record.

2. I am familiar with the land matters involved in the above-referenced case. Copies of Mewbourne’s Application and proposed hearing notice are attached as **Exhibit A-1**.

3. None of the parties proposed to be pooled in this case indicated opposition to this matter proceeding by affidavit, therefore I do not expect any opposition at hearing.

4. Mewbourne applies for an order pooling all uncommitted mineral interests in the Bone Spring formation underlying a 1,271.48-acre, more or less, non-standard horizontal spacing unit comprised of Sections 6 and 7, Township 19 South, Range 35 East in Lea County, New Mexico (“Unit”).

5. Mewbourne seeks to dedicate the Unit to the following wells (“Wells”), which will be completed in the Scharb; Bone Spring Pool (Code 55610):

- a. Beefalo 7/6 State Com #401H to be drilled from a surface hole location in the NW/4 NE/4 (Unit B) of Section 18 to a bottom hole location in the NW/4 NW/4 (Unit D) of Section 6;

- b. Beefalo 7/6 State Com #404H to be drilled from a surface hole location in the NW/4 NE/4 (Unit B) of Section 18 to a bottom hole location in the NE/4 NW/4 (Unit C) of Section 6; and
 - c. Beefalo 7/6 State Com #408H to be drilled from a surface hole location in the NW/4 NE/4 (Unit B) of Section 18 to a bottom hole location in the NE/4 NE/4 (Unit A) of Section 6.
6. The completed intervals of the Wells will be orthodox.
7. **Exhibit A-2** contains the C-102 for the Wells.
8. **Exhibit A-3** contains a plat that identifies ownership by tract in the Unit. This exhibit also includes any applicable lease numbers, a unit recapitulation, and the interests Mewbourne seeks to pool highlighted in yellow.
9. **Exhibit A-4** contains a sample well proposal letter and AFE sent to the working interest owners for the Wells. The estimated costs reflected on the AFE is a fair and reasonable and comparable to the cost of other wells of similar depth and length drilled in the subject formation in the area.
10. Mewbourne has conducted a diligent search of all county public records including phone directories and computer databases. I also used the Accurint subscription service to locate interest owners.
11. In my opinion, Mewbourne made a good-faith effort to reach voluntary joinder of uncommitted interests in the Wells as indicated by the chronology of contact described in **Exhibit A-5**.


12. Mewbourne requests overhead and administrative rates of \$10,000.00 per month while the Wells are being drilled and \$1,000.00 per month while the Wells are producing. These rates are fair and are comparable to the rates charged by Mewbourne and other operators in the vicinity.

13. Mewbourne has submitted an administrative request for approval of a non-standard spacing unit and no objections have been filed. As a result, Mewbourne expects the request will be granted.


14. The attached exhibits were either prepared by me or under my supervision or were compiled from company business records.

APPLICATION

Pursuant to NMSA 1978, § 70-2-17, Mewbourne Oil Company (“Mewbourne” or “Applicant”) (OGRID No. 14744) files this application with the Oil Conservation Division (“Division”) seeking an order pooling all uncommitted mineral interests in the Bone Spring formation underlying a 1,271.48-acre, more or less, non-standard horizontal spacing unit comprised of Sections 6 and 7, Township 19 South, Range 35 East in Lea County, New Mexico (“Unit”). In support of its application, Mewbourne states the following.

1. Applicant is a working interest owner in the Unit and has the right to drill wells thereon.
2. Applicant seeks to dedicate the Unit to the following proposed wells (“Wells”):
 - a. Beefalo 7/6 State Com #401H to be drilled from a surface hole location in the NW/4 NE/4 (Unit B) of Section 18 to a bottom hole location in the NW/4 NW/4 (Unit D) of Section 6;
 - b. Beefalo 7/6 State Com #404H to be drilled from a surface hole location in the NW/4 NE/4 (Unit B) of Section 18 to a bottom hole location in the NE/4 NW/4 (Unit C) of Section 6; and
 - c. Beefalo 7/6 State Com #408H to be drilled from a surface hole location in the NW/4 NE/4 (Unit B) of Section 18 to a bottom hole location in the NE/4 NE/4 (Unit A) of Section 6.
3. The completed intervals of the Wells will be orthodox.

4. Applicant has undertaken diligent, good-faith efforts to obtain voluntary agreements from all interest owners to participate in the drilling of the Wells but has been unable to obtain voluntary agreements from all interest owners.

5. The pooling of uncommitted interests will avoid the drilling of unnecessary wells, prevent waste, and protect correlative rights.

6. Applicant has submitted an administrative request for approval of a non-standard horizontal spacing unit.

7. In order to allow Applicant to obtain its just and fair share of the oil and gas underlying the subject lands, all uncommitted interests in the Unit should be pooled and Applicant should be designated the operator of the proposed horizontal Wells and the Unit.

WHEREFORE, Applicant requests this application be set for hearing before an Examiner of the Oil Conservation Division on July 6, 2023, and, after notice and hearing as required by law, the Division enter an order:

- A. Pooling all uncommitted interests in the Unit;
- B. Approving the initial Wells in the Unit;
- C. Designating Applicant as operator of the Unit and the Wells to be drilled thereon;
- D. Authorizing Applicant to recover its costs of drilling, equipping and completing the Wells;
- E. Approving the actual operating charges and costs of supervision, together with a provision adjusting the rates pursuant to the COPAS accounting procedures; and
- F. Imposing a 200% charge for the risk assumed by Applicant in drilling and completing the wells against any working interest owner who does not voluntarily participate in the drilling of the wells.

**SELF-AFFIRMED STATEMENT
OF JORDAN CARRELL**

1. I am a geologist at Mewbourne Oil Company (“Mewbourne”) and am over 18 years of age. I have personal knowledge of the matters addressed herein and am competent to provide this Self-Affirmed Statement. I have previously testified before the New Mexico Oil Conservation Division (“Division”), and my credentials as an expert in petroleum geology matters were accepted and made a matter of record.

2. I am familiar with the geological matters that pertain to the above-referenced case.

3. **Exhibit B-1** is a location map of the proposed horizontal spacing unit (“Unit”). The approximate wellbore paths for the proposed Beefalo 7/6 State Com #401H, Beefalo 7/6 State Com #404H, and Beefalo 7/6 State Com #408H wells (“Wells”) are represented by dashed lines.

4. **Exhibit B-2** is a subsea structure map for the Bone Spring formation that is representative of the targeted interval. The approximate wellbore paths for the Wells are depicted by dashed lines. Existing producing wells in the targeted interval are represented by solid orange lines. The map demonstrates the formation is gently dipping to the southwest in this area. I do not observe any faulting, pinch-outs, or geologic impediments to developing the targeted intervals with horizontal wells.

5. Exhibit B-2 also identifies four wells penetrating the targeted intervals used to construct a stratigraphic cross-section from A to A’. I used these well logs because they penetrate the targeted intervals, are of good quality, and are representative of the geology in the area.

6. **Exhibit B-3** is a stratigraphic cross-section using the representative wells identified on Exhibit B-2. It contains gamma ray, resistivity and porosity logs. The proposed landing zones for the Wells are labeled on the exhibit. This cross-section demonstrates the target interval is continuous across the Unit.

7. In my opinion, a standup orientation for the proposed wells is appropriate to properly develop the subject acreage because of an established directional pattern and the known fracture orientation in this portion of the trend. A standup orientation is also supported by a study of the production of stand-up versus laydown orientation in the area, with standup well results being significantly better.

8. Based on my geologic study of the area, the targeted interval underlying the Unit is suitable for development by horizontal wells and the tracts comprising the Unit will contribute more or less equally to the production of the Wells.


9. In my opinion, the granting of Mewbourne's application will serve the interests of conservation, the protection of correlative rights, and the prevention of waste.
