**APPLICATION**

Spur Energy Partners LLC (“Spur” or “Applicant”) (OGRID No. 328947), through undersigned attorneys, hereby files this application with the Oil Conservation Division pursuant to the provisions of NMSA 1978, § 70-2-12(B)(10) and 19.15.16.15.C NMAC, for an order approving a non-standard well location. In support of its application, Spur states:

1. Attached is a complete non-standard well location application for Spur’s proposed **Welch B 28 Fed 70H well** (API No. 30-015-49272) that contains the information necessary for approval. It was filed with the Division administratively on May 30, 2023. *See* Administrative Application, attached as **Exhibit A**, and incorporated herein.

2. The spacing unit for this Yeso well is comprised of a 160-acre, more or less, standard horizontal well spacing unit underlying the S/2 N/2 of Section 28, Township 17 South, Range 28 East, Eddy County, New Mexico.

3. The completed interval for this well is unorthodox because it is closer than 330 feet to the outer boundary of the spacing unit and therefore encroaches on the spacing unit to the north, which is operated by Spur. *See* 19.15.16.15.C(1)(a) NMAC.

4. The administrative application was protested by Longfellow Energy LLC. The parties have been unable to resolve Longfellow’s protest. Spur therefore requests that its application be set for hearing pursuant to 19.15.4.12(E) NMAC.

WHEREFORE, Spur Energy Partners LLC requests that this application be set for hearing before an Examiner of the Oil Conservation Division on August 3, 2023, and, after notice and hearing as required by law, the Division enter an order approving this application and granting such other relief as the evidence supports.

Spur Energy Partners LLC respectfully requests administrative approval of a non-standard location on Welch B 28 Fed 70H well, API Number 30-015-49272, Property Code 332213. The 70H well is proposed to be completed in the Artesia; Glorieta-Yeso (O), pool, Pool Code 96830. The proposed wellbore is to be completed within 330’ feet of the N/2 of the N/2 of Section 28. The proposed interval is projected as follows:

First Take Point – 1505’ FNL 100’ FEL Unit H Sec 28 T17S R28E




