## UNOPPOSED MOTION TO VACATE PREHEARING ORDER, AS AMENDED, AND TO HOLD A STATUS CONFERENCE

Devon Energy Production Company, L.P., ("Devon"), through its undersigned attorneys, moves the New Mexico Oil Conservation Division ("Division") to vacate the existing Prehearing Order, as amended ("PHO"), issued for the above-referenced cases ("Tiger Paw Cases") and hold a status conference on July 20, 2023, in lieu of the scheduled hearing. In support, Devon states the following:

- 1. The Bureau of Land Management ("BLM") recently finalized a sale of unleased federal lands located in units that form the subject matter of the Tiger Paw Cases, and a new owner is now included in the proposed units.
- 2. Devon requests additional time to communicate with the new owner, including providing the new owner with proper well proposals.
- 3. Devon also has been able to evaluate its current development plan for the proposed units and requests additional time to revise certain aspects of the current plan which should improve overall operations of the proposed units.
