APPLICATION

Marathon Oil Permian LLC (“Marathon”), OGRID Number 372098, through its undersigned attorneys, hereby files this Application with the Oil Conservation Division (“Division”) pursuant to the provisions of NMSA 1978, § 70-2-17, for an order (1) creating a standard 960-acre, more or less, overlapping horizontal well spacing and unit (“HSU”) composed of the E/2 of Sections 15, 10, and 3, Township 23 South, Range 32 East, N.M.P.M., Lea County, New Mexico, and (2) an order pooling all uncommitted mineral interests in the Wolfcamp Formation, designated as an oil pool, underlying said HSU.

In support of its Application, Marathon states the following:

1. Marathon is a working interest owner in the subject lands and has a right to drill wells thereon.
2. Marathon seeks to dedicate the E/2 of Sections 15, 10, and 3, Township 23 South, Range 32 East, NMPM, Lea County, New Mexico to form a 960-acre, more or less, spacing unit.
3. Marathon seeks to dedicate the above-referenced HSU to the following proposed wells:

- A. **Bing Clawsby WC Federal Com 703H Well**, which is an oil well that will be horizontally drilled from a surface location in the SW $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 15 to a bottom hole location in the Wolfcamp Formation in the NE $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 3; and
- B. **Bing Clawsby WC Federal Com 701H Well and Bing Clawsby WC Federal Com 702H Well**, which are oil wells that will be horizontally drilled from a surface location in the SW $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 15 to a bottom hole location in the Wolfcamp Formation in the NW $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 3.

4. The wells are orthodox in their location, and the take points and laterals comply with Statewide Rules for setbacks.

5. The completed interval for the Bing Clawsby WC Federal Com 702H well is less than 330' from the adjoining tracts and the Division's rules allow for the inclusion of proximity tracts within the proposed standard spacing unit for the wells.

6. Marathon has sought in good faith, but has been unable to obtain, voluntary agreement from all interest owners in the Wolfcamp formation underlying the proposed spacing unit to participate in the drilling of the wells or to otherwise commit their interests to the wells.

7. The pooling of all interests in the Wolfcamp formation within the proposed unit will avoid the drilling of unnecessary wells, prevent waste and protect correlative rights. In order to provide for its just and fair share of the oil and gas underlying the subject lands, Marathon requests that all uncommitted interests in this HSU be pooled and that Marathon be designated the operator of the proposed horizontal wells and HSU.

WHEREFORE, Marathon requests this Application be set for hearing on July 6, 2023, before an Examiner of the Oil Conservation Division, and after notice and hearing as required by law, the Division enter an order:

- A. Approving the creation of a standard 960-acre, more or less, spacing and proration unit comprised of the E/2 of Sections 15, 10, and 3, Township 23 South, Range 32 East, Lea County, New Mexico;
- B. Pooling all uncommitted interests in the Wolfcamp formation underlying a horizontal spacing unit within the E/2 of Sections 15, 10, and 3, Township 23 South, Range 32 East, NMPM, Lea County, New Mexico;
- C. Approving the Bing Clawsby WC Federal Com 701H, Bing Clawsby WC Federal Com 702H Well, and Bing Clawsby WC Federal Com 703H Well as the wells for the HSU.
- D. Designating Marathon as operator of the HSU and the horizontal wells to be drilled thereon;
- E. Authorizing Marathon to recover its costs of drilling, equipping, and completing the wells;
- F. Approving actual operating charges and costs of supervision, to the maximum extent allowable, while drilling and after completion, together with a provision adjusting the rates pursuant to the COPAS accounting procedures; and
- G. Setting a 200% charge for the risk assumed by Marathon in drilling and completing the wells in the event a working interest owner elects not to participate in the wells.

Applicant in the above-styled cause seeks an order from the Division: (1) creating a standard 960-acre, more or less, spacing and proration unit comprised of the E $\frac{1}{2}$ of Sections 15, 10, and 3, Township 23 South, Range 32 East, N.M.P.M, Lea County, New Mexico, and (2) pooling all uncommitted mineral interests in the Wolfcamp formation, designated as an oil pool, underlying said unit. The proposed wells to be dedicated to the horizontal spacing unit are the Bing Clawsby WC Federal Com 703H Well, which is an oil well that will be horizontally drilled from a surface location in the SW $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 15 to a bottom hole location in the Wolfcamp Formation in the NE $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 3, and the Bing Clawsby WC Federal Com 701H Well and Bing Clawsby WC Federal Com 702H Well, which are oil wells that will be horizontally drilled from a surface location in the SW $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 15 to a bottom hole location in the Wolfcamp Formation in the NW $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 3. The wells are orthodox in location and the take points and laterals comply with Statewide Rules for setbacks; also to be considered will be the cost of drilling and completing the wells and the allocation of the costs thereof; actual operating costs and charges for supervision; the designation of the Applicant as Operator of the wells and unit; and a 200% charge for the risk involved in drilling and completing the wells. The wells and lands are located approximately 25 miles from Jal, New Mexico.

AFFIDAVIT OF SAMUEL COX

Samuel Cox, being first duly sworn upon oath, deposes and states as follows:

1. My name is Samuel Cox, and I am employed by Marathon Oil Permian LLC (“Marathon”) as a Senior Land Professional.

2. I have previously testified before the New Mexico Oil Conservation Division (“Division”), and my qualifications as an expert in petroleum land matters were accepted and made a matter of record. I have several years of experience in petroleum land matters, and I have worked directly or in a supervisory role with the properties that are the subject of these matters.

3. I am submitting this affidavit in support of Marathon’s applications in the above-referenced cases pursuant to 19.15.4.12.(A)(1) NMAC.

4. I am familiar with the applications filed by Marathon in these consolidated cases and the status of the lands in the subject lands.

5. Under Case No. 23574, Marathon seeks an order (1) creating a standard 960-acre, more or less, overlapping horizontal well spacing and unit (“HSU”) composed of the E/2 of Sections 15, 10, and 3, Township 23 South, Range 32 East, N.M.P.M., Lea County, New Mexico,

and (2) an order pooling all uncommitted mineral interests in the Wolfcamp Formation, designated as an oil pool, underlying said HSU.

6. **Marathon Exhibit C-1** is a general location map showing the proposed Wolfcamp Formation spacing unit. The acreage subject to the applications are federal lands.

7. **Marathon Exhibit C-2** contains the Form C-102s reflecting that the proposed Wolfcamp wells to be drilled and completed in the subject unit. The location of each well is orthodox and meets the Division's offset requirements.

8. A review of the Wolfcamp Formation underlying the subject lands indicated that there are no overlapping spacing units in the Wolfcamp Formation.

9. **Marathon Exhibit C-3** outlines the proposed Wolfcamp unit and tracts therein.

10. **Marathon Exhibit C-4** sets forth the parties being pooled, the nature of their interests, and their last known address. The exhibit identifies the tract number, tract percentage interest, and spacing unit percentage interest for each mineral owner. In compiling these addresses, I conducted a diligent search of the public records in Lea County, New Mexico, where the wells are located, and of phone directories and did computer searches to locate the contact information for parties entitled to notification. All interest owners were locatable and noticed, and there are no unleased mineral interest owners. Marathon caused notice to be published in the Hobs News-Sun, a newspaper of general circulation in Lea County, New Mexico. I provided the law firm of Beatty & Wozniak, P.C. with the names and addresses for these mineral owners and instructed that each owner be provided notice of the hearing in these matters.

11. **Marathon Exhibit C-5** sets forth a chronology of the contacts with owners. Marathon has made a good faith effort to obtain voluntary joinder of the interest owners in the proposed wells.

12. As of the date of this testimony, there are no uncommitted unleased mineral owners or uncommitted lessees in the unit. Accordingly, Marathon is omitting an election letter, lease offer letter, and authorization for expenditure from this testimony because the documents are inapplicable to Applicant's requested relief.

13. Marathon is not seeking an order recovering the proportionate share of well costs or a charge for risk associated with the drilling, completion or working over of the unit wells from any uncommitted owner.

14. Marathon requests that it be designated operator of the unit and wells.

15. **Exhibit C-1** through **Exhibit C-5** were either prepared by me or compiled from Marathon's company business records under my direction and supervision.

16. The granting of these applications is in the best interest of conservation, the prevention of waste, and the protection of correlative rights, and will avoid the drilling of unnecessary wells.

17. I hereby swear that to the best of my knowledge and belief, all of the matters set forth herein and in the exhibits are true, correct, and accurate.



PUBLIC ACCESS ROAD MAP






Elizabeth Scully, being first duly sworn upon oath, deposes and states as follows:

1. My name is Elizabeth Scully, and I am employed by Marathon Oil Permian LLC (“Marathon”) as an Advanced Geologist.
2. I have previously testified before the New Mexico Oil Conservation Division (“Division”), and my credentials as an expert in petroleum geology matters were accepted and made a matter of record. I have 9 years of experience in petroleum geological matters, and I am familiar with the subject applications and the geology involved.
3. I am submitting this affidavit in support of Marathon’s applications in the above-referenced cases pursuant to 19.15.4.12.(A)(1) NMAC.
4. **Marathon Exhibit D-1** is a locator map of the lands showing the proposed Wolfcamp formation spacing unit.
5. **Marathon Exhibit D-1** is a cross section reference map of the lands showing the proposed Wolfcamp formation spacing unit and wells.
6. **Marathon Exhibit D-3** is a structure map showing the depth (subsea) to the top of the Wolfcamp formation, a marker that defines the top of the target interval for the proposed wells. Contour interval of 25'. The unit being pooled is outlined in bold, and the proposed wells are

identified. The structure map shows regional down-dip to the southeast. I do not observe any faulting, pinchouts, or other geologic impediments to developing this target interval.

7. **Marathon Exhibit D-4** is a stratigraphic cross-section flattened on the top of the Wolfcamp formation. Each well in the cross-section contains a gamma ray, resistivity, and porosity log. The cross-section demonstrates continuity and consistent thickness across the target zone, and the well logs on the cross-section give a representative sample of the targeted interval. The landing zone is highlighted on the exhibit.

8. Based on the attached exhibits, I hereby conclude as follows:

a. The target formation is present and continuous throughout the lands subject to the applications.

b. The horizontal spacing and proration unit is justified from a geologic standpoint.

c. There are no structural impediments or faulting that will interfere with horizontal development.

d. Each quarter-quarter section in the unit will contribute more or less equally to production, and I can confirm each quarter section along the lateral will also contribute more or less equally to production.

e. The preferred well orientation in this area is North-South so that the wells run sub-perpendicular to the inferred orientation of the maximum horizontal stress.

9. **Exhibit D-1** through **Exhibit D-4** were prepared by me or compiled from Marathon's company business records under my direct supervision.

10. The granting of these applications is in the best interest of conservation, the prevention of waste, and the protection of correlative rights, and will avoid the drilling of unnecessary wells.

11. I hereby swear that to the best of my knowledge and belief, all of the matters set forth herein and in the exhibits are true, correct, and accurate.




Locator Map – Bing Clawsby Federal Com Unit




