STATEMENT OF THE CASE

APPLICANT

Case No. 23762: Mewbourne Oil Company seeks an order pooling all uncommitted mineral interest owners in the Lower Bone Spring formation underlying a horizontal spacing unit comprised of the E/2W/2 of Section 23 and the E/2W/2 of Section 26, Township 18 South, Range 32 East, NMPM. The unit will be dedicated to the Querecho 23/26 Fed. Com. Well No. 616H, to be drilled to a depth sufficient to test the Lower Bone Spring formation, with a first take point in the NE/4NW/4 of Section 23 and a last take point in the SE/4SW/4 of Section 26.

Case No. 23763: Mewbourne Oil Company seeks an order pooling all uncommitted mineral interest owners in the Lower Bone Spring formation underlying a horizontal spacing unit comprised of the W/2E/2 of Section 23 and the W/2E/2 of Section 26, Township 18 South, Range 32 East, NMPM. The unit will be dedicated to the Querecho 23/26 Fed. Com. Well No. 523H, to be drilled to a depth sufficient to test the Lower Bone Spring formation, with a first take point in the NW/4NE/4 of Section 23 and a last take point in the SW/4SE/4 of Section 26.

Also to be considered will be the cost of drilling, completing, testing, and equipping the wells and the allocation of the cost thereof, as well as actual operating costs and charges for supervision, designation of applicant as operator of the wells, and a 200% charge for the risk involved in drilling, completing, testing, and equipping the wells.

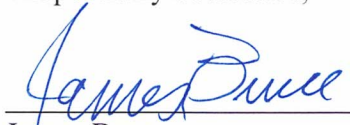
