To Whom It May Concern:

Matador Production Company has proposed the above-referenced wells for the development of the Bone Spring formation under the S/2 N/2 of Section 33 and the S/2 NE/4 of Section 32, Township 20 South, Range 30 East, NMPM, Eddy County, New Mexico.

This letter is to advise you that this proposed development plan will require the formation of the 240 acre, more or less, spacing unit comprised of the S/2 N/2 of Section 33 and the S/2 NE/4 of Section 32, Township 20 South, Range 30 East, NMPM, Eddy County, New Mexico, which will initially be dedicated to:

- (i) Matador's **Alyson 3332 Fed Com 202H** well to be horizontally drilled from a surface hole location in the NE/4 NE/4 (Unit A) of Section 33-T20S-R30E, with a first take point in the SE/4 NE/4 (Unit H) of Section 33 and a last take point in the SW/4 NE/4 (Unit G) of Section 32-T20S-R30E. This well is targeting the Wolfcamp A-XY of the Wolfcamp formation, with an approximate TVD of 10,065'.

Matador's proposed 240-acre spacing unit will overlap the following existing 40-acre spacing unit comprised of the SW/4 NE/4 (Unit G) of Section 32-T20S-R30E, which is currently dedicated to the following well:

- (i) Matador Production Company's Eddy BD State #3 (30-015-38144), which is a vertical well with the surface hole location and bottom hole location located in the SW/4 NE/4 (Unit G) of Section 32-T20S-R30E. This well is targeting the Wolfcamp B of the Wolfcamp formation, with an approximate TVD of 10,110'; and

Pursuant to NMAC 19.15.16.15.B(9) and 19.15.15.12.B, you have a right to object the overlapping spacing unit by delivering a written statement of objection to our office within twenty (20) days of the mailing of this notice. If no objection is received within this 20-day period, we will proceed with obtaining any remaining regulatory approvals for the proposed spacing unit.
