MOTION TO VACATE PREHEARING ORDER

Colgate Production, Colgate Operating and Permian Resources Operating (collectively “Permian Resources”) move to vacate the prehearing order in these cases, entered on August 3, 2023, and in support thereof states:

1. Permian Resources filed an entry of appearance and objection to these cases proceeding by affidavit on July 26, 2023.
2. Following a status conference, the Division Examiner set these cases for a contested hearing on September 21, 2023.
3. Following discussions between Permian Resources and Mewbourne Oil Company (“Mewbourne”), Permian Resources has agreed to withdraw its objection to Case Nos. 23689-23691 proceeding to hearing by affidavit on September 21, 2023. Permian Resources has filed a separate notice withdrawing its objection in those cases.
4. Permian Resources and Mewbourne have also agreed to continue Case No. 23688 to a status conference on October 19, 2023. Permian Resources will file a separate unopposed motion to continue that case.
5. Accordingly, there is no longer a need for a contested hearing in Case Nos. 23689-23691 or for a prehearing order in any of these cases.

WHEREFORE, movants respectfully request that the Division vacate the prehearing order for Case Nos. 23688-23691 and set Case Nos. 23689-23691 for an uncontested hearing on September 21, 2023.
