**APPLICANT'S STATEMENT OF THE CASE**

Under these consolidated cases, MRC seeks orders pooling all uncommitted interests in the Bone Spring formation underlying the referenced acreage all in Township 24 South, Range 33 East, NMPM, Lea County, New Mexico, as follows:

- Under **Case No. 23625**, MRC seeks an order (a) approving a standard 319.98-acre, more or less, overlapping horizontal well spacing unit in the Bone Spring formation comprised of Lot 4, SW/4 NW/4, and the W/2 SW/4 of Section 2, and the W/2 W/2 of Section 11, and (b) pooling all uncommitted mineral interests in this overlapping horizontal well spacing unit. MRC seeks to initially dedicate this overlapping horizontal well spacing unit to the proposed **Charles Ling Fed Com #135H** well, to be horizontally drilled from a surface location in the NW/4 NW/4 (Unit D) of Section 2 to a bottom hole location in the SW/4 SW/4 (Unit M) of Section 11. This 319.98-acre horizontal well spacing unit will overlap the following existing horizontal well spacing units covering portions of the subject acreage:

- 160-acre, more or less, horizontal well spacing unit comprised of the N/2 N/2 of Section 2, Township 24 South, Range 33 East, dedicated to the Macho State #1H (API: 30-025-39884);
  - 160-acre, more or less, horizontal well spacing unit comprised of the S/2 N/2 of Section 2, Township 24 South, Range 33 East, dedicated to the Macho State #2H (API: 30-025-39885);
  - 160-acre, more or less, horizontal well spacing unit comprised of the N/2 S/2 of Section 2, Township 24 South, Range 33 East, dedicated to the Trucker “Brk” State #1H (API: 30-025-26309);
  - 160-acre, more or less, horizontal well spacing unit comprised of the S/2 S/2 of Section 2, Township 24 South, Range 33 East, dedicated to the Trucker “Brk” State #2H (API: 30-025-41972); and
  - 160-acre, more or less, horizontal well spacing unit comprised of the W/2 W/2 of Section 11, Township 24 South, Range 33 East, dedicated to the Roy Batty Federal Com #1H (API: 30-025-41099).
- Under **Case No. 23626**, MRC seeks an order (a) approving a standard 319.85-acre, more or less, overlapping horizontal well spacing unit in the Bone Spring formation comprised of Lot 3, SE/4 NW/4, and the E/2 SW/4 of Section 2, and the E/2 W/2 of Section 11, and (b) pooling all uncommitted mineral interests in this overlapping horizontal well spacing unit. MRC seeks to initially dedicate this overlapping horizontal well spacing unit to the proposed **Charles Ling Fed Com #136H** well, to be horizontally drilled from a surface location in the NE/4 NW/4 (Unit C) of Section 2 to a bottom hole location in the SE/4 SW/4 (Unit N) of Section 11. This 319.85-acre horizontal well spacing unit will overlap

the following existing horizontal well spacing units covering portions of the subject acreage:

- 160-acre, more or less, horizontal well spacing unit comprised of the N/2 N/2 of Section 2, Township 24 South, Range 33 East, dedicated to the Macho State #1H (API: 30-025-39884);
  - 160-acre, more or less, horizontal well spacing unit comprised of the S/2 N/2 of Section 2, Township 24 South, Range 33 East, dedicated to the Macho State #2H (API: 30-025-39885);
  - 160-acre, more or less, horizontal well spacing unit comprised of the N/2 S/2 of Section 2, Township 24 South, Range 33 East, dedicated to the Trucker “Brk” State #1H (API: 30-025-26309);
  - 160-acre, more or less, horizontal well spacing unit comprised of the S/2 S/2 of Section 2, Township 24 South, Range 33 East, dedicated to the Trucker “Brk” State #2H (API: 30-025-41972); and
  - 160-acre, more or less, horizontal well spacing unit comprised of the E/2 W/2 of Section 11, Township 24 South, Range 33 East, dedicated to the Roy Batty Federal Com #2H (API: 30-025-41332).
- Under **Case No. 23627**, MRC seeks an order (a) approving a standard 319.73-acre, more or less, overlapping horizontal well spacing unit in the Bone Spring formation comprised of Lot 2, SW/4 NE/4, and the W/2 SE/4 of Section 2, and the W/2 E/2 of Section 11, and (b) pooling all uncommitted mineral interests in this overlapping horizontal well spacing unit. MRC seeks to initially dedicate this overlapping horizontal well spacing unit to the proposed **Charles Ling Fed Com #137H** well, to be horizontally drilled from a surface

location in the NW/4 NE/4 (Unit B) of Section 2 to a bottom hole location in the SW/4 SE/4 (Unit O) of Section 11. This 319.73-acre horizontal well spacing unit will overlap the following existing horizontal well spacing units covering portions of the subject acreage:

- 160-acre, more or less, horizontal well spacing unit comprised of the N/2 N/2 of Section 2, Township 24 South, Range 33 East, dedicated to the Macho State #1H (API: 30-025-39884);
  - 160-acre, more or less, horizontal well spacing unit comprised of the S/2 N/2 of Section 2, Township 24 South, Range 33 East, dedicated to the Macho State #2H (API: 30-025-39885);
  - 160-acre, more or less, horizontal well spacing unit comprised of the N/2 S/2 of Section 2, Township 24 South, Range 33 East, dedicated to the Trucker “Brk” State #1H (API: 30-025-26309);
  - 160-acre, more or less, horizontal well spacing unit comprised of the S/2 S/2 of Section 2, Township 24 South, Range 33 East, dedicated to the Trucker “Brk” State #2H (API: 30-025-41972); and
  - 160-acre, more or less, horizontal well spacing unit comprised of the W/2 E/2 of Section 11, Township 24 South, Range 33 East, dedicated to the Roy Batty Federal Com #3H (API: 30-025-41333).
- Under **Case No. 23628**, MRC seeks an order (a) approving a standard 479.6-acre, more or less, overlapping horizontal well spacing unit in the Bone Spring formation comprised of Lot 1, SE/4 NE/4, and the E/2 SE/4 of Section 2, and the E/2 E/2 of Sections 11 and 14, and (b) pooling all uncommitted mineral interests in this overlapping horizontal well

spacing unit. MRC seeks to initially dedicate this overlapping horizontal well spacing unit to the proposed **Charles Ling Fed Com #138H** well, to be horizontally drilled from a surface location in the NE/4 NE/4 (Unit A) of Section 2 to a bottom hole location in the SE/4 SE/4 (Unit P) of Section 14. This 479.6-acre horizontal well spacing unit will overlap the following existing horizontal well spacing units covering portions of the subject acreage:

- 160-acre, more or less, horizontal well spacing unit comprised of the N/2 N/2 of Section 2, Township 24 South, Range 33 East, dedicated to the Macho State #1H (API: 30-025-39884);
- 160-acre, more or less, horizontal well spacing unit comprised of the S/2 N/2 of Section 2, Township 24 South, Range 33 East, dedicated to the Macho State #2H (API: 30-025-39885);
- 160-acre, more or less, horizontal well spacing unit comprised of the N/2 S/2 of Section 2, Township 24 South, Range 33 East, dedicated to the Trucker “Brk” State #1H (API: 30-025-26309);
- 160-acre, more or less, horizontal well spacing unit comprised of the S/2 S/2 of Section 2, Township 24 South, Range 33 East, dedicated to the Trucker “Brk” State #2H (API: 30-025-41972);
- 160-acre, more or less, horizontal well spacing unit comprised of the E/2 E/2 of Section 11, Township 24 South, Range 33 East, dedicated to the Roy Batty Federal Com #4H (API: 30-025-41334); and

- o 160-acre, more or less, horizontal well spacing unit comprised of the E/2 E/2 of Section 14, Township 24 South, Range 33 East, dedicated to the Tyrell Fee #1H (API: 30-025-41026) and the Tyrell Fee #2H (API: 30-025-42789).

The completed interval for each of the wells will comply with statewide setbacks for oil wells. MRC has sought and been unable to obtain voluntary agreement for the development of these lands from all working interest owners in the subject acreage.
