**APPLICANT’S STATEMENT OF THE CASE**

Permian Resources seeks orders pooling all uncommitted mineral interests in the Bone Spring formation underlying the referenced acreage within Sections 5 and 6, Township 19 South, Range 28 East, NMPM, Eddy County, New Mexico, as follows:

- Under **Case No. 23825**, Permian Resources seeks to pool a standard 320-acre, more or less, horizontal well spacing comprised of S/2 S/2 of Sections 5 and Section 6, and initially dedicate this Bone Spring spacing unit to the proposed **Lone Eagle 5 State Com 124H** and **Lone Eagle 5 State Com 134H** wells, to be horizontally drilled from a surface location in the NE/4 SE/4 (Unit I) of Section 5, Township 19 South, Range 28 East, to bottom hole locations in the SW/4 SW/4 (Unit M) of Section 6, Township 19 South, Range 28 East.
- Under **Case No. 23826**, Permian Resources seeks to pool a standard 320-acre, more or less, horizontal well spacing comprised of N/2 S/2 of Sections 5 and Section 6, and initially dedicate this Bone Spring spacing unit to the proposed **Lone Eagle 5 State Com 123H** and **Lone Eagle 5 State Com 133H** wells, to be horizontally drilled from a surface location in the NE/4 SE/4 (Unit I) of Section 5, Township 19

South, Range 28 East, to bottom hole locations in the NW/4 SW/4 (Unit L) of Section 6, Township 19 South, Range 28 East.

- Under **Case No. 23827**, Permian Resources seeks to pool a standard 320-acre, more or less, horizontal well spacing comprised of S/2 N/2 of Sections 5 and Section 6, and initially dedicate this Bone Spring spacing unit to the proposed **Lone Eagle 5 State Com 122H** and **Lone Eagle 5 State Com 132H** wells, to be horizontally drilled from a surface location in the SE/4 NE/4 (Unit H) of Section 5, Township 19 South, Range 28 East, to bottom hole locations in the SW/4 NW/4 (Unit E) of Section 6, Township 19 South, Range 28 East.

The completed interval for each of the wells will meet the statewide setbacks for oil wells. Permian Resources has sought and been unable to obtain voluntary agreement for the development of these lands from all working interest owners in the subject acreage.
