STATEMENT OF THE CASES

In **Case No. 22949**, Mewbourne applies for an order pooling additional uncommitted interests under the terms of Division Order No. R-22818. Order No R-22818 pooled uncommitted interests in the Bone Spring formation underlying a non-standard horizontal spacing unit comprised of Sections 6 and 7, Township 19 South, Range 35 East, Lea County, New Mexico.

Order No. R-22818 further dedicated the Unit to the Beefalo 7/6 State Com #401H, #404H, and #408H wells and designated Applicant as operator of the Unit and wells.

In Case No. 22950, Mewbourne applies for an order pooling additional uncommitted interests under the terms of Division Order No. R-22819. Order No R-22819 pooled uncommitted interests in the Wolfcamp formation underlying a non-standard horizontal spacing unit comprised of the E/2 of Sections 6 and 7, Township 19 South, Range 35 East, Lea County, New Mexico. Order No. R-22819 further dedicated the Unit to the Beefalo 7/6 State Com #716H well and designated Applicant as operator of the Unit and well.

Since Order Nos. R-22818 and R-22819 were entered, Applicant has identified additional interests in the Units that should be pooled under the terms of the Orders.

The wells are located approximately 18 miles west of Hobbs, New Mexico.
