APPLICANT'S STATEMENT OF THE CASE

Under these consolidated cases, Permian seeks orders pooling all uncommitted interests in the Bone Spring (Ojo Chiso; Bone Spring [96553]) formation underlying the referenced acreage all in Township 21 South, Range 35 East, NMPM, Lea County, New Mexico, as follows:

- In **Case No. 24028**, Permian seeks an order (a) approving a standard 320-acre, more or less, overlapping horizontal well spacing unit in an interval of the Bone Spring formation comprised of the W/2 E/2 of Section 31, Township 21 South, Range 35 East, and the W/2 E/2 of Section 6, Township 22 South, Range 35 East, NMPM, Lea County, New Mexico, and (b) pooling all uncommitted mineral interests in the correlative stratigraphic interval from 9,465 feet TVD to 9,660 feet TVD, that being the First Bone Spring, as shown in the New Mexico 'DA' State #001 (API: 30-025-27360). Permian proposes to dedicate the above-referenced spacing unit to the proposed initial **Eric Cartman 6 State Com 303H** well, to be horizontally drilled from a surface location and with a first take point in the SW/4 SE/4 (Unit O) of Section 6, Township 22 South, Range 35 East and a bottom hole location in the NW/4 NE/4 (Unit B) of Section 31, Township 21 South, Range 35 East. This 320-acre horizontal well spacing unit will overlap the following existing horizontal well spacing unit:
 - 160-acre horizontal well spacing unit comprised of the W/2 E/2 of Section 31, Township 21 South, Range 35 East, dedicated to the Eric Cartman 31 State Com 504H (API: 30-025-50159) and Eric Cartman 31 State Com 505H (API: 30-025-50160).
- In **Case No. 24029**, Permian seeks an order (a) approving a standard 320-acre, more or less, overlapping horizontal well spacing unit in an interval of the Bone Spring formation comprised of the E/2 E/2 of Section 31, Township 21 South, Range 35 East, and the E/2 E/2 of Section 6, Township 22 South, Range 35 East, NMPM, Lea County, New Mexico, and (b) pooling all uncommitted mineral interests in the correlative stratigraphic interval from 9,465 feet TVD to 9,660 feet TVD, that being the First Bone Spring, as shown in the New Mexico 'DA' State #001 (API: 30-025-

27360). Permian proposes to dedicate the above-referenced spacing unit to the proposed initial **Eric Cartman 6 State Com 304H** well, to be horizontally drilled from a surface location in the SW/4 SE/4 (Unit O) of Section 6, Township 22 South, Range 35 East, a first take point in the SE/4 SE/4 (Unit P) of Section 6, Township 22 South, Range 35 East, and a bottom hole location in the NE/4 NE/4 (Unit A) of Section 31, Township 21 South, Range 35 East. This 320-acre horizontal well spacing unit will overlap the following existing horizontal well spacing unit:

- o 400-acre horizontal well spacing unit comprised of the E/2 E/2 of Section 31, Township 21 South, Range 35 East, and the E/2 E/2 of Section 6 and the E/2 NE/4 of Section 7, Township 22 South, Range 35 East, NMPM, Lea County, New Mexico, dedicated to the Eric Cartman 31 State Com 506H (API: 30-025-50161) well.¹

The completed interval for the wells will comply with statewide setbacks for oil wells. Permian has sought and been unable to obtain voluntary agreement for the development of these lands from all interest owners in the subject acreage.
