



Enclosed is a copy of an application, filed with the New Mexico Oil Conservation Division by Mewbourne Oil Company, requesting the following relief:

Case No. 24039: Mewbourne Oil Company seeks an order pooling all uncommitted mineral interest owners in the Bone Spring formation underlying a horizontal spacing unit comprised of the S/2S/2 of Section 12, Township 21 South, Range 25 East, N.M.P.M., and the S/2S/2 of Section 7 and the SW/4SW/4 of Section 8, Township 21 South, Range 26 East, N.M.P.M., Eddy County, New Mexico. The unit will be dedicated to the Stage Fright 12/8 Fed. Com. Well No. 618H, with a first take point in the SW/4SW/4 of Section 12 and a last take point in the SW/4SW/4 of Section 8.

This matter is scheduled for hearing at 8:15 a.m. on Thursday, January 18, 2024. During the current circumstances, state buildings are closed to the public and the hearing will be conducted remotely. 
**Although the well unit is a standard horizontal well unit, the Oil Conservation Division requested that notice of the hearing be given to the Bureau of Land Management because the SE/4SW/4 of Section 8, Township 21 South, Range 26 East, N.M.P.M., is unleased federal minerals.** Of course, pooling and well charges are not being sought against the Bureau of Land Management
