- 1. I am over the age of 18, and have personal knowledge of the matters stated herein.
- 2. I am a geologist for Mewbourne Oil Company ("Mewbourne"), and I am familiar with the geological matters involved in these cases. I have been qualified by the Division as an expert petroleum geologist.
  - 3. The following plats are attached hereto:
  - (a) Exhibit 3-A is an area locator plat.
  - (b) Exhibit 3-B is a structure map on the top of the Second Bone Spring Sand in the area around Sections 26 and 35, Township 23 South, Range 28 East, NMPM. It shows that structure dips gently to the east. It also shows existing and proposed First and Second Bone Spring wells in the area. It also shows a north-south line of cross-section.
  - (c) Exhibit 3-C is a north-south cross section of the First Bone Spring Sand, and Exhibit 3-D is a north-south cross section of the Second Bone Spring Sand. The logs on the cross-sections give a representative sample of the First and Second Bone Spring Sands in this area. The sands are continuous and of relatively uniform thickness across the well units.
  - 4. I conclude from the maps that:

Mewbourne Oil Company applies for an order pooling all uncommitted mineral interest owners in the Bone Spring formation underlying a horizontal spacing unit comprised of the E½W½ of Section 26 and the E½W½ of Section 35, Township 23 South, Range 28 East, N.M.P.M., Eddy County, New Mexico, and in support thereof, states:

- 1. Applicant is an interest owner in the  $E\frac{1}{2}W\frac{1}{2}$  of Section 26 and the  $E\frac{1}{2}W\frac{1}{2}$  of Section 35 (covering 320 acres), and has the right to drill a well or wells thereon.

- E. Setting a 200% charge for the risk involved in drilling, completing, and equipping the wells in the event a working interest owner elects not to participate in the wells.

Mewbourne Oil Company seeks an order pooling all uncommitted mineral interest owners in the Bone Spring formation underlying a horizontal spacing unit comprised of the E½W½ of Section 26 and the E½W½ of Section 35, Township 23 South, Range 28 East, N.M.P.M., Eddy County, New Mexico. Applicant proposes to drill the following wells on the unit to depths sufficient to test the Bone Spring formation:

- (a) The Layla 26/35 Fee Well No. 404H, with a first take point in the NE¼NW¼ of Section 26 and a last take point in the SE¼SW¼ of Section 35; and
