**STATEMENT OF THE CASES**

In Case No. 24126, Colgate seeks an order pooling all uncommitted interests in the Bone Spring formation underlying a 280-acre, more or less, standard horizontal spacing unit comprised of the SW/4 SE/4 and S/2 SW/4 of Section 25, and the S/2 S/2 of Section 26, Township 19 South, Range 30 East, Eddy County, New Mexico. The Unit will be dedicated to the **Morbucks 25-26 Federal Com 114H, Morbucks 25-26 Federal Com 124H, and Morbucks 25-26 Federal Com**

**134H** wells, which will be drilled from surface hole locations in the SW/4 SE/4 (Unit O) of Section 25, to bottom hole locations in the SW/4 SW/4 (Unit M) of Section 26.

In Case No. 241247, Colgate seeks an order pooling all uncommitted interests in the Bone Spring formation underlying a 280-acre, more or less, standard horizontal spacing unit comprised of the NW/4 SE/4 and N/2 SW/4 of Section 25, and the N/2 S/2 of Section 26, Township 19 South, Range 30 East, Eddy County, New Mexico. The Unit will be dedicated to the **Morbucks 25-26 Federal Com 113H, Morbucks 25-26 Federal Com 123H, and Morbucks 25-26 Federal Com 133H** wells, which will be drilled from surface hole locations in the SW/4 SE/4 (Unit O) of Section 25, to bottom hole locations in the NW/4 SW/4 (Unit L) of Section 26.

The completed intervals of the wells will be orthodox. Also to be considered will be the cost of drilling and completing the wells and the allocation of the costs, the designation of Permian Resources Operating, LLC as operator of the wells, and a 200% charge for the risk involved in drilling and completing the wells.

The wells are located approximately 23 miles northeast of Carlsbad, New Mexico.
