**APPLICATION**

Fasken Oil & Ranch, LTD (“Fasken” or “Applicant”), through its undersigned attorneys, hereby files this application with the Oil Conservation Division to extend the drilling deadline under compulsory pooling Order No. R-22122. In support of its application, Fasken states:

1. On May 9, 2022, the Division entered Order R-22122 in Case 22698 pooling the Bone Spring formation underlying a standard 320-acre horizontal well spacing unit comprised of the E/2 W/2 of Sections 22 and 15, Township 20 South, Range 32 East, NMPM, Lea County, New Mexico (the “Pooling Order”). Fasken is the designated operator under the Pooling Order and the pooled spacing unit is initially dedicated to the proposed **Baetz 22/15 Fed Com 2H** (API: 30-025-PENDING) well.

2. On June 7, 2023, the Division entered Order R-22122-A in Case 23474 extending until May 9, 2024, the deadline to drill the initial well under the Pooling Order. At the Division hearing, Fasken demonstrated the drilling permit filed with the Bureau of Land Management had not yet been approved.

3. As of the filing of this application, the drilling permit on file with the Bureau of Land Management has still not been approved.

4. Good cause exists to extend the deadline to commence drilling the initial well under the Pooling Order.

WHEREFORE, Applicant requests that this application be set for hearing before an Examiner of the Oil Conservation Division on May 2, 2024, and, after notice and hearing as required by law, the Division enter an order extending until May 9, 2025, the deadline to commence drilling the initial well under the Pooling Order.

**SELF-AFFIRMED STATEMENT OF MIKE WALLACE**

1. My name is Mike Wallace, and I work for Fasken Oil & Ranch, LTD, (“Fasken”) as a Landman. I am familiar with the applications filed in these cases and have personal knowledge of the information provided in this self-affirmed statement.

2. I have previously testified before the New Mexico Oil Conservation Division (“Division”) as an expert witness in petroleum land matters. My credentials as a landman have been accepted by the Division and made a matter of record.

3. Case 24396 seeks to amend Order R-22121 and Case 24397 seeks to amend Order R-22122 to allow additional time to drill the initial, approved wells. Both orders were entered on May 9, 2022, and created standard 320-acre horizontal well spacing units in the Bone Spring formation underlying the W2W2 and the E2W2 (respectively) of Sections 22 and 15, Township 20 South, Range 32 East, NMPM, Lea County, New Mexico, for the proposed **Baetz 22/15 Fed Com #1H** and **Baetz 22/15 Fed Com #2H** wells.

4. The drilling deadline for each of these wells was extended until May 9, 2024, under Orders R-22121-A (Case 23473) and R-22122-A (Case 23474) because the drilling permits filed with the Bureau of Land Management on June 30, 2022, had not yet been approved.

5. Since the drilling permits remain pending before the Bureau of Land Management, good cause remains to further extend the deadline to commence drilling under the orders for another year, until May 19, 2025.

6. Since Fasken is still waiting for approved drilling permits, none of the working interest owners that remain subject to these pooling orders have been asked to make an election on the wells or pay their estimated share of the costs to drill, complete and equip the wells.

7. The granting of this application will prevent waste and protect correlative rights.

8. I affirm under penalty of perjury under the laws of the State of New Mexico that the foregoing statements are true and correct. I understand that this self-affirmed statement will be used as written testimony in these cases. This statement is made on the date next to my signature below.




