Under Case No. 24538, EOG seeks an order pooling all uncommitted interests in the Upper Bone Spring formation (Red Hills Upper Bone Spring Shale Pool, Pool Code 97900) comprised of the W/2 of Sections 15, 22, and 27, Township 25 South, Range 34 East, NMPM, Lea County, New Mexico. This spacing unit will be initially dedicated to the **Pistolero 15 Fed Com #202H** well, to be horizontally drilled from a surface location in the NW/4 NW/4 (Unit D) of Section 15 to a bottom hole location in the SE/4 SW/4 (Unit N) of Section 27; and the **Pistolero 15 Fed Com**

#203H well, to be horizontally drilled from a surface location in the NW/4 NW/4 (Unit D) of Section 15 to a bottom hole location in the SW/4 SW/4 (Unit M) of Section 27.

Applicant filed a separate administrative application for approval of the non-standard spacing unit.

The completed interval for the wells will comply with statewide setbacks for oil wells.

EOG has sought and been unable to obtain voluntary agreement for the development of these lands from all interest owners in the subject acreage.
