# **STATEMENT OF THE CASES**

In Case Nos. 24525, 24526, and 24527, BTA requests a one (1) year extension of time to commence drilling the Capitan 22301 28-33 State Com #9H, Capitan 22301 28-33 State Com #10H, and Capitan 22301 28-33 State Com #11H wells ("Wells"). The Division issued Order Nos. R-22724, R-22725, and R-22736 on June 7, 2023, approving the Wells and designating BTA operator of the Units and the Wells. Good cause exits for the Division to grant a one (1) year of extension of time for BTA to commence drilling the Wells because BTA's ability to drill the Wells

has been delayed by limited gas takeaway capacity in the area. BTA requests that the Division extend the deadline to commence drilling the Wells to June 7, 2025.
