APPLICANT’S STATEMENT OF THE CASES

In **Case No. 24835**, Permian Resources seeks an order to amend Order No. R-22894 (“Order”) to allow additional time to commence drilling the initial well authorized by the pooling Order.

On October 9, 2023, the Division issued Order No. R-22894 in Case No. 22555, creating a standard 1,920-acre, more or less, horizontal well spacing unit in Wolfcamp formation (Purple Sage; Wolfcamp Gas Pool [98220]) comprised of Section 36, Township 21 South, Range 26 East, and irregular Sections 31 and 32, Township 21 South, Range 27 East, NMPM, Eddy County, New Mexico (the “Unit”). SPC Resources, LLC was designated as operator and Order No. R-22894 dedicates the Unit to the proposed initial **Fred State Com 403H** and **Fred State Com 442H** wells.

There is good cause for Applicant’s request for an extension of time to drill. Permian has since acquired this property and requests that Order No. R-22894 be re-opened and amended to allow Applicant additional time to commence drilling the wells under the Order. Under the Order, Applicant would be required to commence drilling the well by October 10, 2024, and, therefore, asks for the deadline to commence drilling the well be extended for a year, to October 10, 2025.

In **Case No. 24837**, Permian Resources seeks an order to amend Order No. R-22893 (“Order”) to allow additional time to commence drilling the initial well authorized by the pooling Order.

On October 9, 2023, the Division issued Order No. R-22893 in Case No. 22554, creating a standard 1,282.24-acre, more or less, horizontal well spacing unit in Wolfcamp formation (Purple Sage; Wolfcamp Gas Pool [98220]) comprised of Sections 1 and 2, Township 22 South, Range 26 East, NMPM, Eddy County, New Mexico (the “Unit”). SPC Resources, LLC was designated as

operator and Order No. R-22893 dedicates the Unit to the proposed initial **Water Buffalo 402H** well.

There is good cause for Applicant’s request for an extension of time to drill. Permian has since acquired this property and requests that Order No. R-22893 be re-opened and amended to allow Applicant additional time to commence drilling the well under the Order.
