**BRIEF IN SUPPORT OF MOTION TO STRIKE AMERICAN ENERGY RESOURCES
ENTRY OF APPEARANCE AND NOTICE OF OPPOSITION**

Permian Resources Operating, LLC (“Permian”), through undersigned attorneys, hereby submits this additional brief on title pursuant to the instructions of the Hearing Examiner in this matter.

FACTS AND BACKGROUND

1. On November 11, 2024, Permian filed a compulsory pooling application.
2. On November 27, 2024, American Energy Resources, LLC (“American Energy”) (OGRID 372991), emailed an entry of appearance and notice of objection in Permian’s case.
3. In response, Permian filed the same day a motion to strike and response to American Energy’s filing, arguing that based on Permian’s title examination American Energy did not own an interest in the proposed horizontal well spacing unit and therefore was not entitled to enter and appearance or object to the pooling proceedings. Permian further responded to American Energy’s claim that Permian did not own an interest in its proposed development, showing that it owned over 90% of the working interest.¹ See Lease Index and Certificate of Merger from the State of New Mexico Secretary of State, Exhibit A.
4. American Energy filed a reply on December 2, 2024, in which it lodged a variety of different claims, along with a statement from Lindsey Sandoval attesting to an interest owned by Jonathan Samaniego in Permian’s proposed development area.

5. On December 3, 2024, the Division Hearing Examiner set a preliminary hearing for December 5, 2024, to test the validity of the evidence submitted by each party. In the meantime, Permian's landman, Collin Christian, reached out to American Energy's representative, Mr. Samaniego, to try to understand the bases of the interest claimed. Mr. Samaniego was uncooperative.

6. At the preliminary hearing, American Energy's witness, Ms. Sandoval, was cross-examined by Permian's counsel and asked by the Division Hearing Examiner to provide a copy of the instrument she examined to Permian. Ms. Sandoval emailed a copy of the instrument to Permian's counsel. That Tax Deed has now been filed in the Division case file for this matter and is attached as Exhibit C.

7. The Division Hearing Examiner further instructed Permian to review the instrument from American Energy and provide a summary of its findings.

ARGUMENT

There Is No Interest Held By American Energy In This Acreage And A Gap in Title Appears to Exist For The Tax Deed To Jonathon R. Samaniego.

The acreage subject to the Tax Deed provided by Ms. Sandoval consists of approximately 1/10th of an acre, located in the SE/4 of Section 7, Township 22 South, Range 27 East, sandwiched between a railroad right-of-way and highway. *See* Tax Assessor Plat Map (blue highlighted area), Exhibit B. The acreage was listed for sale by the tax accessor's office and purchased by Jonathan R. Samaniego due to a delinquency in tax payment by the previous owner for \$39.20. *See* Delinquent Property Tax List for Eddy County (2020) (dated July 6, 2023) and New Mexico Property Tax Division County Sale (dated June 21, 2023), Exhibit C (yellow highlights).

For its investigation, Permian's third-party title examiner, Schoeffler Energy Group ("SEG"), first began chaining title from the instrument provided by Ms. Sandoval going back to patent in the following sequence:

- Book 1174, Page 1196 - Deed, dated 7/26/2023, filed 9/19/2023, by the Property Tax Division of the Taxation and Revenue Department of the State of New Mexico to Jonathan R. Samaniego;
- Book 1172, Page 670 - 2020 Delinquent Property Tax List for Eddy County, dated 7/6/2023, filed 7/6/2023, by the Eddy County Treasurer. (RE: unpaid property taxes assessed to Cavern City Cinemas, Inc.);
- Book 1172, Page 161 - Updated Final Property Tax List for Eddy (2019) County Sale of June 21, 2023, dated 6/21/2023, filed 6/21/2023, by the State of New Mexico Property Tax Division. This instrument shows that the subject property will be deeded to Jonathan R. Samaniego. (RE: unpaid property taxes assessed to Cavern City Cinemas, Inc.);
- Book 184, Page 1069 - Quitclaim Deed, dated 4/6/1994, filed 4/6/1994, by Bradley T. Light to Cavern City Cinemas, Inc.; and
- Book 171, Page 843 - Quitclaim Deed, dated 10/15/1993, filed 11/1/1993, by Andrew C. Bindel, Jr. and Rita H. Bindel, his wife, to Bradley T. Light.

See Exhibit C.

However, upon getting to the 1993 quitclaim deed, SEG found a gap in title that it has been unable to resolve. *See* Statement from David Schoeffler, Exhibit D. As a result, Mr. Schoeffler is unable to determine whether Jonathon R. Samaniego owns any interest in the mineral estate underlying this surface acreage conveyed by the Tax Deed. Permian's counsel reached out to Ms. Sandoval and Mr. Samaniego, explaining the gap in title found and requesting information or assistance to clarify. Mr. Samaniego refused to provide any assistance but did ask Permian for clarification on several of its leases, which Permian provided. *See* Emails: RE_Into Samaniego and RE: Case No. 24963 Att: Paula Vance, Exhibit E.

SEG is currently conducting a title examination from the patent forward in furtherance of its investigation into the matter; however, the title is complex and will take additional time to finalize. In any event, any interest in the acreage subject to the Tax Deed is held by Jonathon R. Samaniego, not American Energy Resources, LLC, the entity which has entered an appearance and objected to this matter. With respect to any dispute over the interest held by Jonathon R. Samaniego, the Division is not the forum for adjudicating the matter. *See* OCD Order R-11700-B (“The Division has no jurisdiction to determine the validity of any title, or the validity or continuation in force and effect of any oil and gas lease. Exclusive jurisdiction of such matters resides in the courts of the State of New Mexico.”).²

CONCLUSION

Even if the instrument provided by Mr. Samaniego is valid and conveys an interest in the mineral estate underlying the surface acreage, the entry of appearance and objection was filed by American Energy—who is not the purported interest owner.³ No evidence has been provided that American Energy owns anything in Permian’s proposed development area. As a result, Permian’s motion to strike should be granted because only a party entitled to notice may enter an appearance to an adjudicatory proceeding before the Division. 19.15.4.10.A NMAC. American Energy owns nothing, has no right to send proposals or file competing applications, and has no grounds for filing an entry of appearance or objection to this matter or anything related to the subject lands.

WHEREFORE, Permian respectfully requests that American Energy’s entry of appearance and notice of opposition to presentation by affidavit be excluded from consideration by the Division and that Permian be allowed to move forward with its pooling application.

RECITALS

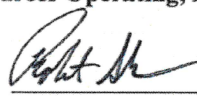

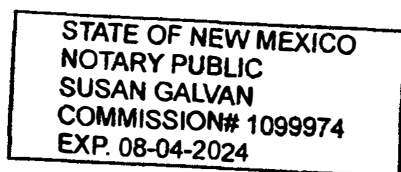

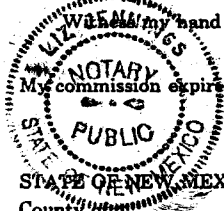
