APPLICANT’S STATEMENT OF CASE

In this case, 3R seeks orders to approve standard 640-acre, more or less, horizontal spacing unit (“HSU”) composed of the S/2 of Sections 32 and 33, Township 23 South, Range 26 East, N.M.P.M., Eddy County, New Mexico (the “Application Lands”), and to pool all

uncommitted mineral interests in the Wolfcamp formation, designated as an oil pool, underlying said HSU.

Under **Case 25124**, 3R seeks to pool the Wolfcamp formation underlying the Application Lands and seeks dedicate the HSU to the following proposed wells:

A. **Crystal N 33 32 Fed Com #703H**, which is an oil well that will be horizontally drilled from a surface location in the SE/4 of Section 33 to a bottom hole location in the Wolfcamp Formation in the NW/4 SW/4 (Unit L) of Section 32;

B. **Crystal N 33 32 Fed Com #803H**, which is an oil well that will be horizontally drilled from a surface location in the SE/4 of Section 33 to a bottom hole location in the Wolfcamp Formation in the NW/4 SW/4 (Unit L) of Section 32;

C. **Crystal N 33 32 Fed Com #804H**, which is an oil well that will be horizontally drilled from a surface location in the SE/4 of Section 33 to a bottom hole location in the Wolfcamp Formation in the SW/4 SW/4 (Unit M) of Section 32;

The wells are orthodox in their location as defined by 19.15.16.15.(C) NMAC, and the take points and laterals comply with Statewide Rules for setbacks under 19.15.16.15.(C) NMAC. Also to be considered will be the cost of drilling and completing the Wells and the allocation of the cost, the designation of Applicant as the operator of the Wells, and a 200% charge for the risk involved in drilling and completing the Wells.

The wells and lands are located approximately 6 miles southwest from Carlsbad, New Mexico.
