**RESPONSE TO NOTICE OF INTERVENTION**

Read & Stevens, Inc. and Permian Resources Operating, LLC (collectively “Permian”), hereby submits this response to Carolyn Beall’s (“Beall”) notice of intervention.

Permian does not dispute that Ms. Beall owns an interest in the NE/4 NW/4 of Section 14, Township 18 South, Range 31 East, NMPM, Eddy County, New Mexico. However, Permian is

not aware of any instrument of record showing that Ms. Beall owns an interest in the S/2 NE/4, NE/4 NE/4, NW/4 NE/4, SE/4 NW/4 of Section 14, Township 18 South, Range 31 East, NMPM, Eddy County, New Mexico. Permian is prepared to discuss this at the February 27, 2025 continuation contested hearing.

As to the other assertions made in the motion, Ms. Beall received sufficient notice because she, in fact, entered an appearance prior to the January 28, 2025 contested hearing and had counsel present. *See Exhibit A* – Beall Entry of Appearance and Objection. Further, because the Division Hearing Examiner left the record open and continued the contested hearing to the February 27, 2025 docket, Permian’s notice in Case Nos. 25145-15148 (and the Division’s Public Notice concerning the same)<sup>1</sup> will be perfected or “proper” at said hearing; thus, meeting the Division’s notice requirements and timelines under 19.15.4.9 and 19.15.4.12 NMAC.

No order has been issued in Case Nos. 25145-15148 and the Division completed reasonable notice. *See* NMSA 1978, §70-2-23. Neither Ms. Beall, nor V-F Petroleum Inc., have provided a valid reason to dismiss Permian’s Case Nos. 25145-15148. If anything, the Division should strike Ms. Beall’s entry of appearance in Permian’s Case Nos. 25147 and 25148, since Ms. Beall has provided no evidence to support that she is an affected party entitled to notice or a party with standing.
