APPLICANT'S STATEMENT OF THE CASE

In Case No. 24872, Avant seeks an order pooling all uncommitted interests within the Wolfcamp Formation, designated as an oil pool (E.K.; Wolfcamp Pool, Pool Code 21670) underlying a non-standard 1262.79-acre, more or less, horizontal well spacing unit comprised of Sections 30 and 31, Township 18 South, Range 34 East, N.M.P.M., Lea County, New Mexico. Applicant seeks to initially dedicate this horizontal spacing unit to the proposed **Speedmaster 30 Fed Com #006H** and **#007H** wells ("Wells"):

- i. **Speedmaster 30 Fed Com #006H** well with a proposed surface hole location in the NE/4 NW/4 (Unit C) of Section 30 and a proposed bottom hole location in the SE/4 SW/4 (Unit N) of Section 31;
- ii. **Speedmaster 30 Fed Com #007H** well with a proposed surface hole location in the NW/4 NW/4 (Unit D) of Section 30 and a proposed bottom hole location in the SW/4 SW/4 (Unit M) of Section 31;
- iii. The application originally included the following wells, which we no longer seek to initially dedicate to the Spacing Unit:
 1. **Speedmaster 30 Fed Com #008H** well with a proposed surface hole location in the NE/4 NE/4 (Unit A) of Section 30 and a

proposed bottom hole location in the SW/4 SE/4 (Unit O) of Section 31;

- 2. **Speedmaster 30 Fed Com #009H** well with proposed first take point in the NE/4 NE/4 (Unit A) of Section 30 and proposed last take points in the SE/4 SE/4 (Unit P) of Section 31;

The completed interval for each well will be orthodox and comply with statewide setbacks for oil wells. Avant has sought and been unable to obtain voluntary agreement for the development of these lands from all working interest owners in the subject acreage.
