**APPLICANT'S STATEMENT OF CASE**

In Case No. 25198, Alpha seeks an order pooling all uncommitted mineral interests in the Bone Spring formation, designated as an oil pool, underlying a standard 317.15-acre, more or less, horizontal spacing unit comprised of Lot 2, SE/4 NW/4, and S/2 NE/4 (a/k/a S/2 N/2) of Section 19 and the S/2 N/2 of Section 20 in Township 22 South, Range 27 East, Eddy County, New Mexico.

1. Alpha is a working interest owner in the proposed horizontal spacing unit ("HSU") and has a right to drill a well thereon.

2. Alpha seeks to have the Division designate Paloma Permian AssetCo, LLC ("Paloma") (OGRID No. 332449) as the operator of the proposed horizontal wells and HSU.

3. Alpha proposes and dedicates to the HSU two (2) initial wells: **The Dude Fee 20-19 503H** and **The Dude Fee 20-19 553H** to be drilled to a sufficient depth to test the Bone Spring formation.

4. Alpha proposes **The Dude Fee 20-19 503H** to be horizontally drilled from a surface location in the NE/4 NE/4 (Unit A) of Section 20 to a bottom hole location of Lot 2 (SW/4 NW/4) of Section 19.

5. Alpha proposes **The Dude Fee 20-19 553H** to be horizontally drilled from a surface location in the NE/4 NE/4 (Unit A) of Section 20 to a bottom hole location of Lot 2 (SW/4 NW/4) of Section 19.

6. All the wells proposed herein are orthodox in their location, and the take points and completed intervals comply with setback requirements under the Division’s statewide rules.
