MOTION TO AMEND PRE-HEARING ORDER

Cimarex Energy Co. ("Cimarex") respectfully moves to amend the Pre-Hearing Order setting the above captioned cases for a contested hearing on April 29, 2025, to add a recently filed case to the Pre-Hearing Order. In support, Cimarex states:

1. On March 11, 2025, Cimarex filed an application seeking to pool uncommitted interests in a 1280-acre more or less non-standard Bone Spring horizontal spacing unit, which was assigned Case No. 25259. This case is a replacement case for existing Case No. 25102.
2. Cimarex intends to dismiss Case No. 25102 upon granting of this motion.
3. Case No. 25259 is currently set on the April 10, 2025 Examiner Docket. Cimarex will file a continuance for Case No. 25259 to the April 29, 2025 contested hearing date upon granting of this motion
4. The February 27, 2025 Pre-Hearing Order should thus be amended to add Cimarex Case No. 25259.
5. Counsel for MRC Permian was contacted and does not object to the motion.
6. Counsel for XTO Permian Operating LLC was contacted and does not object to the motion.

7. Counsel for ConocoPhillips was contacted and does not object to the motion.
