**STATEMENT OF THE CASES**

In **Case No. 25262**, Mewbourne seeks an order pooling additional uncommitted interests under the terms of Division Order No. R-22195-A. The Order pooled all uncommitted interests in

the Wolfcamp formation underlying a non-standard horizontal spacing unit comprised of the W/2 of Sections 6 and 7, Township 19 South, Range 35 East, Lea County New Mexico. The Order further dedicated the Unit to the Beefalo 7/6 State Com #713H (W1NC) well and designated Mewbourne as operator of the Unit and the well. The Division subsequently entered Order No. R-22195-B, which pooled additional interests under the terms of the Order. Since Order No. R-22195-B was entered, Mewbourne has identified additional interests in the Unit that should be pooled under the terms of the Order.

In **Case No. 25260**, Mewbourne seeks an order pooling additional uncommitted interests under the terms of Division Order No. R-22818. The Order pooled all uncommitted interests in the Bone Spring formation underlying a non-standard horizontal spacing unit comprised of Sections 6 and 7, Township 19 South, Range 35 East, Lea County, New Mexico. The Order further dedicated the Unit to the Beefalo 7/6 State Com #401H, Beefalo 7/6 State Com #404H, and the Beefalo 7/6 State Com #408 wells, and designated Mewbourne as operator of the Unit and the wells. The Division subsequently entered Order No. R-22818-A, which pooled additional interests under the terms of the Order. Since Order No. R-22818-A was entered, Mewbourne has identified additional interests in the Unit that should be pooled under the terms of the Order.

In **Case No. 25261**, Mewbourne seeks an order pooling additional uncommitted interests under the terms of Division Order No. R-22819. The Order pooled all uncommitted interests in the Wolfcamp formation underlying a non-standard horizontal spacing unit comprised of the E/2 of Sections 6 and 7, Township 19 South, Range 35 East, Lea County, New Mexico. The Order further dedicated the Unit to the Beefalo 7/6 State com #716H well and designated Mewbourne as operator of the Unit and the wells. The Division subsequently entered Order No. R-22819-A, which pooled additional interests under the terms of the Order. Since Order No. R-22819-A was

entered, Mewbourne has identified additional interests in the Unit that should be pooled under the terms of the Order.
