STATEMENT OF THE CASE

In these matters, Applicant MRC Permian Company (“Applicant” or “MRC”) seeks orders pooling all uncommitted interests in horizontal well spacing units underlying Sections 11 and 14, Township 17 South, Range 37 East, NMPM, Lea County, New Mexico. Fasken has a working interest in the proposed units. However, MRC failed to act in good faith to negotiate a voluntary agreement as required by NMSA 1978, Section 70-2-18. MRC failed to provide a well proposal to Fasken 30 days prior to filing the applications AND/OR failed to provide timely notice of the hearing. No witness testimony by the Trust or on its behalf is anticipated, but the Trust reserves the right to cross-examine Applicant’s witnesses. Although the parties have reached an agreement in principle, MRC has failed to provide an acceptable form of agreement in writing. Fasken has submitted a proposed form of agreement for MRC’s review and awaits a response from MRC.
