APPLICANT'S STATEMENT OF THE CASE

In Case No. 25193, V-F seeks an order pooling all uncommitted mineral interests in the Bone Spring formation, designated as an oil pool, underlying a non-standard 1,906.34-acre, more or less, spacing unit comprised of all of Sections 36, 35 and 34, in Township 19 South, Range 27 East, NMPM, Eddy County, New Mexico as follows:

- Under Case No. 25193, V-F Petroleum dedicates to the unit and proposes as an initial well the **Angel Ranch 36-34 Fed Com #221H Well**, an oil well, to be horizontally drilled from a surface location in the SE/4 SE/4 (Unit P) of Section 36 to a bottom hole location in the SW/4 SW/4 (Unit M) of Section 34.

- Also under Case No. 25193, V-F Petroleum dedicates to the unit and proposes as an initial well the **Angel Ranch 36-34 Fed Com #231H Well**, an oil well, to be horizontally drilled from a surface location in the SE/4 SE/4 (Unit P) of Section 36 to a bottom hole location in the SW/4 SW/4 (Unit M) of Section 34.
- Also under Case No. 25193, V-F Petroleum dedicates to the unit and proposes as an initial well the **Angel Ranch 36-34 Fed Com #222H Well**, an oil well, to be horizontally drilled from a surface location in the SE/4 SE/4 (Unit P) of Section 36 to a bottom hole location in the NW/4 SW/4 (Unit L) of Section 34.
- Also under Case No. 25193, V-F Petroleum dedicates to the unit and proposes as an initial well the **Angel Ranch 36-34 Fed Com #232H Well**, an oil well, to be horizontally drilled from a surface location in the SE/4 SE/4 (Unit P) of Section 36 to a bottom hole location in the NW/4 SW/4 (Unit L) of Section 34.
- Also under Case No. 25193, V-F Petroleum dedicates to the unit and proposes as an initial well the **Angel Ranch 36-34 Fed Com #223H Well**, an oil well, to be horizontally drilled from a surface location in the NE/4 NE/4 (Unit A) of Section 36 to a bottom hole location in the SW/4 NW/4 (Unit E) of Section 34.
- Also under Case No. 25193, V-F Petroleum dedicates to the unit and proposes as an initial well the **Angel Ranch 36-34 Fed Com #233H Well**, an oil well, to be horizontally drilled from a surface location in the NE/4 NE/4 (Unit A) of Section 36 to a bottom hole location in the SW/4 NW/4 (Unit E) of Section 34.
- Also under Case No. 25193, V-F Petroleum dedicates to the unit and proposes as an initial well the **Angel Ranch 36-34 Fed Com #224H Well**, an oil well, to be horizontally drilled from a surface location in the NE/4 NE/4 (Unit A) of Section 36 to a bottom hole location in the NW/4 NW/4 (Unit D) of Section 34.
- Also under Case No. 25193, V-F Petroleum dedicates to the unit and proposes as an initial well the **Angel Ranch 36-34 Fed Com #234H Well**, an oil well, to be horizontally drilled

from a surface location in the NE/4 NE/4 (Unit A) of Section 36 to a bottom hole location in the NW/4 NW/4 (Unit D) of Section 34.

The proposed wells are orthodox in their locations, and the take points and completed intervals comply with setback requirements under the statewide rules.
