**SELF-AFFIRMED STATEMENT
OF JOSEPH KENT**

1. I am over 18 years of age and am competent to provide this self-affirmed statement. I have personal knowledge of the matters addressed herein. I am employed by FAE II Operating, LLC ("FAE") as the Vice President of Land and Business Development. I have previously testified before the New Mexico Oil Conservation Division ("Division") and my credentials as an expert in petroleum land matters were accepted and made a matter of record.

2. I am familiar with the Application in this case and with the land matters pertaining to this Application. A copy of the application and proposed notice are attached as **Exhibit A-1**.

3. FAE's Application seeks an Order to extend the vertical limits of the Langlie-Mattix; Seven Rivers-Queen-Grayburg Pool (Pool Code 37240) to include the Yates and Upper Seven Rivers formations within the boundaries of the North Jal (Yates-Seven Rivers-Queen) Unit.

4. On January 13, 2025, the Division issued Order No. R-23638 approving the North Jal (Yates-Seven Rivers-Queen) Unit ("Unit") for enhanced oil recovery operations in the Yates, Seven Rivers, and Queen formations.

5. The Unit encompasses approximately 3,154.37 acres of the following federal, state, and fee lands located in Lea County, New Mexico:

6. FAE is the designated operator of the Unit.
7. Order No. R-23638 defines the Unitized Interval as the top of the Yates formation to a lower limit at the base of the Queen formation; the geologic markers having been previously found to occur at 2,879 feet and 3,691 feet, respectively, in Skelly Oil company's Sherrill Well No. 7 (current well name Langlig Jal Unit Well No. 17; API No. 30-025-11301), located at 1,980 feet from the South line and 1,930 feet from the East line of Section 31, Township 24 south, Range 37 East, Lea County, New Mexico, as recorded on the Frontier Perforators, Inc., Gamma Ray-Neutron Log run taken on September 1, 1957, said log being measured from a Kelly Bushing elevation of 3,241 feet above sea level. *See* Order No. R-23628 at ¶ 3.
8. As stated in Order No. R-23638, the Unitized Interval includes the Jalmat; Tan-Yates-Seven Rivers (Oil) Pool (Pool Code 33820), the Langlie-Mattix; Seven Rivers-Queen-Grayburg Pool (Pool Code 37240), and the Yates, Seven Rivers, and Queen formations.
9. In order to allow for the most efficient well development pattern and maximize administrative reporting and efficiency, FAE proposes to expand the vertical limits of the Langlie-

Mattix; Seven Rivers-Queen-Grayburg Pool (Pool Code 37240) to include the Yates and entire Seven Rivers formations, only within the boundaries of the Unit.

10. The expansion of the vertical limits of the Langlie-Mattix; Seven Rivers-Queen-Grayburg Pool (Pool Code 37240) to include the Yates and Upper Seven Rivers formations will allow for the maximization of administrative reporting and efficiency.

11. FAE conducted a diligent, good-faith effort to identify the correct addresses of persons entitled to notice and has complied with the Division's notice requirements.

12. FAE provided notice to all operators within the affected pools, as well as to operators in the same formation as the pool within one (1) mile of the pool's outer boundary as required by 19.15.4.12(A)(4) NMAC. A sample notice letter is attached as **Exhibit A-2** and the return receipts are attached as **Exhibit A-3**.

13. The attached exhibits were either prepared by me or under my supervisor or were compiled from company business records.

14. In my opinion, the granting of FAE's application would serve the interests of conservation, the protection of correlative rights, and the prevention of waste.

15. I understand that this Self-Affirmed Statement will be used as written testimony in the subject cases. I affirm that my testimony above is true and correct and is made under penalty of perjury under the laws of the State of New Mexico. My testimony is made as of the date next to my signature below.

1. I am over 18 years of age and am competent to provide this self-affirmed statement. I have personal knowledge of the matters addressed herein. I am employed by FAE II Operating, LLC ("FAE") as a geologist. I am familiar with the Application in this case and with the geology matters pertaining to this Application. I have previously testified before the New Mexico Oil Conservation Division ("Division") and my credentials as an expert in petroleum geology matters were accepted and made a matter of record.

2. FAE's Application seeks an Order to extend the vertical limits of the Langlie-Mattix; Seven Rivers-Queen-Grayburg Pool (Pool Code 37240) to include the Yates and Upper Seven Rivers formations within the boundaries of the North Jal (Yates-Seven Rivers-Queen) Unit ("Unit").

3. The Unitized Interval is identified in **Exhibit B-1** by a stratigraphic cross section, using the Yates formation top as the reference datum. The cross section shows that porous, reservoir-quality rock is present in the Unitized Interval across the entire Unit and is relatively consistent.

4. The Unitized Interval includes the includes the Jalmat; Tan-Yates-Seven Rivers (Oil) Pool (Pool Code 33820), Langlie-Mattix; Seven Rivers-Queen-Grayburg Pool (Pool Code

37240); and the Yates, Seven Rivers, and Queen formations. **Exhibit B-2** is a map that depicts the pools that include the Yates, Seven Rivers, and/or Queen formations within the Unit.



8. In my opinion, the granting of FAE's application would serve the interests of conservation, the prevention of waste, and the protection of correlative rights.

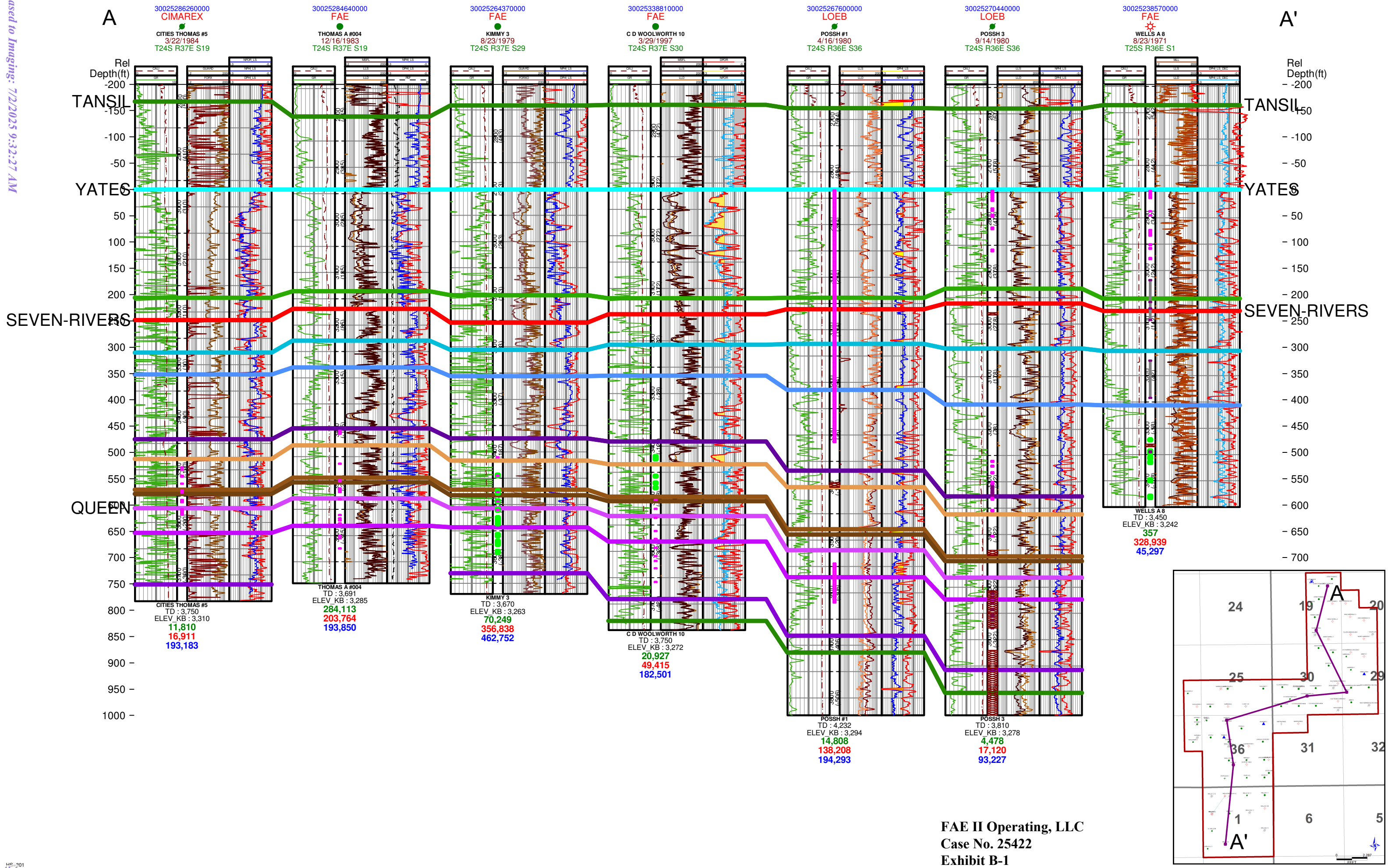

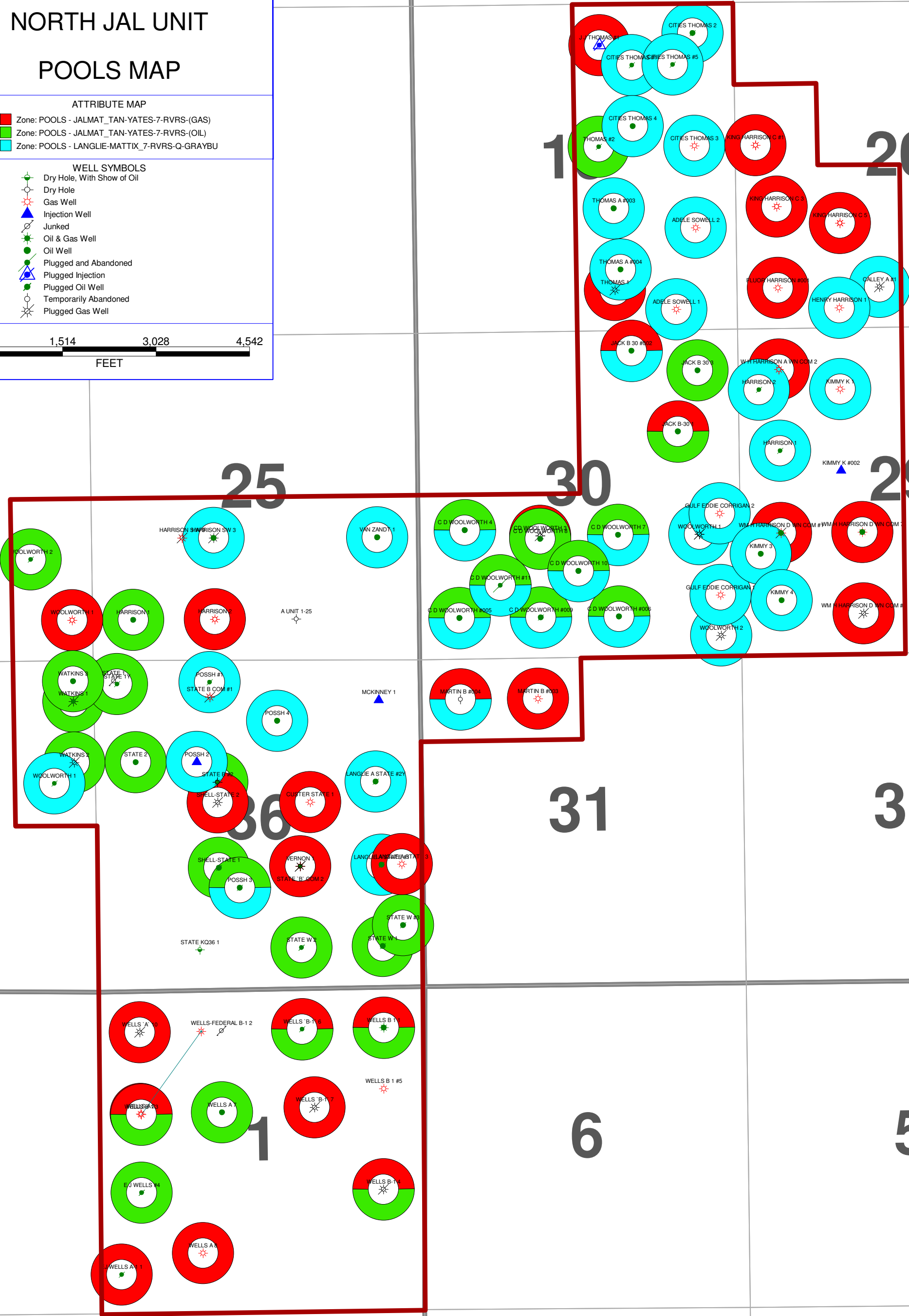
