**SELF-AFFIRMED STATEMENT OF TREY CORTEZ**


1. My name is Trey Cortez, and I work for Burnett Oil Co., Inc., managing partner of Burnett Oil Company ("Burnett") as a Geologist. I am over 18 years of age and am competent to provide the Self-Affirmed Statement. I have personal knowledge of the matters addressed herein.
2. I have previously testified before the New Mexico Oil Conservation Division as an expert witness in petroleum geological matters that pertain to Burnett's applications and my credentials as an expert petroleum geologist have been accepted by the Division and been made a matter of record.
3. A general location map of the proposed horizontal spacing unit ("HSU") outlined by a red box within the Northwest Shelf play outline is attached as Exhibit B-1.
4. A structure map of the top of the Yeso formation with a contour interval of 50 feet is attached as Exhibit B-2. The map shows that the structure dips gently to the southeast across the entire HSU. It also shows a line of cross section (blue A-A') and the HSU for the proposed well paths of The Maverick 1H, The Maverick 2H, and The Maverick 3H wells.
5. Attached Exhibit B-3 is a northwest to southeast cross section. The well logs on the cross section provide a representative sample of the Yeso formation in the area. The target zone for the proposed well is continuous across the HSU and indicated by color fill. The landing zone is also indicated by a yellow arrow.
6. Attached as Exhibit B-4 is a table containing production data from other Yeso wells drilled in the vicinity as well as their correlative productive target designation. The preference is for laydown wells (west to east or east to west) although economic wells have been drilled south to north in the area. Completed wells in the area (recent completions) apparently are commercial.
7. There are no depth severances in the Yeso formation in the proposed HSU
8. Based on the information discussed above, I am able to conclude that:
  - a. The HSU is justified from a geologic standpoint.
  - b. There is no faulting or other geologic impediment that could adversely affect the drilling of the proposed wells; and
  - c. Each quarter-quarter section in the HSU will contribute more or less equally to production.

LOCATOR MAP




## STRUCTURE MAP



Burnett Oil Company has filed the enclosed application with the New Mexico Oil Conservation Division (Case No. 25428) requesting approval of a proximity tract spacing unit in the Atoka Glorieta-Yeso Pool (Pool Code 3250) comprised of the S/2 of Section 24, Township 18 South, Range 26 East, NMPM, Eddy County, New Mexico (the "Unit"), and pooling all uncommitted mineral interest owners in the Glorieta-Yeso formation underlying the Unit. Applicant proposes to drill the following wells in the Unit:

- (a) The Maverick Well No. 1H, with a first take point in the NE/4SE/4 and a last take point in the NW/4SW/4 of Section 24;
- (b) The Maverick Well No. 2H, with a first take point in the NE/4SE/4 and a last take point in the NW/4SW/4 of Section 24; and
- (c) The Maverick Well No. 3H, with a first take point in the SE/4SE/4 and a last take point in the SW/4SW/4 of Section 24.

Also to be considered will be the cost of drilling, completing, testing, and equipping the Wells, and the allocation of the cost thereof among the Wells' working interest owners, approval actual operating charges and costs charged for supervision, together with a provision adjusting the rates pursuant to the COPAS accounting procedure, and setting a 200% charge for the risk involved in drilling, completing, testing, and equipping the Wells in the event a working interest owner elects not to participate in the Wells.


