**STATEMENT OF THE CASE**

Applicant seeks an order pooling all uncommitted interests in the San Andres formation underlying a 320-acre, more or less, standard horizontal spacing unit comprised of the S/2 of Section 27, Township 17 South, Range 27 East, Eddy County, New Mexico (“Unit”). The Unit will be dedicated to the following wells (“Wells”): Big Eagle Federal Com 110H well, which will be drilled from a surface hole location in the SW/4 SW/4 (Unit M) of Section 26 to a bottom hole location in the NW/4 SW/4 (Unit L) of Section 27; and Big Eagle Federal Com 111H well, which will be drilled from a surface hole location in the SW/4 SW/4 (Unit M) of Section 26 to a bottom

hole location in the SW/4 SW/4 (Unit M) of Section 27. The completed intervals of the Wells will be orthodox. The completed interval of Big Eagle Federal Com 110H well will be located within 330' of the quarter-quarter section line separating the N/2 S/2 and S/2 S/2 of Section 27 to allow for the creation of a 320-acre, more or less, standard horizontal spacing unit.

Also to be considered will be the cost of drilling and completing the Wells, the allocation of the costs, the designation of Applicant as operator of the Wells and the Unit, and a 200% charge for the risk involved in drilling and completing the Wells.
