STATEMENT OF THE CASE

Applicant seeks an order pooling all uncommitted interests in the San Andres formation underlying a 160-acre, more or less, standard horizontal spacing unit comprised of the N/2 S/2 of Section 29, Township 17 South, Range 28 East, Eddy County, New Mexico (“Unit”). The Unit will be dedicated to the **Smithdale C Federal Com 110H** well (“Well”), which will be drilled from a surface hole location in the NE/4 SE/4 (Unit I) of Section 30, Township 17 South, Range 28 East, to a bottom hole location in the NE/4 SE/4 (Unit I) of Section 29, Township 17 South, Range 28 East. The completed interval of the Well will be orthodox. Also to be considered will be

the cost of drilling and completing the Well, the allocation of the costs, the designation of Applicant as operator of the Well and the Unit, and a 200% charge for the risk involved in drilling and completing the Well.
