STATEMENT OF THE CASE

Applicant seeks an order pooling all uncommitted interests in the Bone Spring formation underlying a 640-acre, more or less, non-standard horizontal spacing unit comprised of Section 26, Township 22 South, Range 28 East, Eddy County, New Mexico ("Unit"). The Unit will be dedicated to the following u-turn wells ("Wells"):

• Crocubot Federal 26 212H, which will produce from a first take point located in the SW/4 SW/4 (Unit M) to a last take point located in the SE/4 SW/4 (Unit N);

- Crocubot Federal 26 414H, which will produce from a first take point located in the SE/4 SE/4 (Unit P) to a last take point located in the SW/4 SE/4 (Unit O);
- Crocubot Federal 26 231H, which will produce from a first take point located in the SW/4 SW/4 (Unit M) to a last take point located in the SE/4 SW/4 (Unit N); and
- Crocubot Federal 26 304H, which will produce from a first take point located in the SE/4 SE/4 (Unit P) to a last take point located in the SW/4 SE/4 (Unit O).

Permian Resources also requests approval of a non-standard horizontal spacing unit pursuant to Rule 19.15.16.15(B)(5) NMAC, which will create cost efficiencies, prevent waste, and protect correlative rights.

The completed intervals of the Wells will be orthodox. Also to be considered will be the cost of drilling and completing the Wells, the allocation of the costs, the designation of Applicant as operator of the Units and the Wells, and a 200% charge for the risk involved in drilling and completing the Wells.
