**STATEMENT OF THE CASES**

In **Case No. 25617**, Applicant requests a one-year extension of time, until October 23, 2026, to complete drilling operations for the wells authorized by Order No. R-23522. The Division issued Order R-23522 in Case No. 24706 on October 23, 2024. Order No. R-23522: (1) pooled uncommitted interests in the Wolfcamp formation underlying a 1,920-acre, non-standard

horizontal spacing unit comprised of Sections 27, 28, and 29, Township 20 South, Range 27 East, Eddy County, New Mexico; (2) dedicated the unit to the **Pinta 29/27 Fed Com 711H** and **Pinta 29/27 Fed Com 716H** wells; and (3) designated Applicant as operator of the unit and Pinta 29/27 Fed Com 711H and Pinta 29/27 Fed Com 716H wells.

In **Case No. 25618**, Applicant requests a one-year extension of time, until October 23, 2026, to complete drilling operations for the wells authorized by Order No. R-23521. The Division issued Order No. R-23521 in Case No. 24705 on October 23, 2024. Order No. R-23521: (1) pooled uncommitted interests in the Bone Spring formation underlying a 1,920-acre, non-standard horizontal spacing unit comprised of Sections 27, 28, and 29, Township 20 South, Range 27 East, Eddy County, New Mexico; (2) dedicated the unit to the **Pinta 29/27 Fed Com 528H**, **Pinta 29/27 Fed Com 613H** and **Pinta 29/27 Fed Com 618H** wells; and (3) designated Applicant as operator of the unit and Pinta 29/27 Fed Com 528H, Pinta 29/27 Fed Com 613H, and Pinta 29/27 Fed Com 618H wells.

Good cause exists for the requested one-year extension of time to complete drilling the Pinta 29/27 Fed Com wells, because the wells have been spud, however, Mewbourne is still in the process of drilling and completing the wells.
