STATEMENT OF THE CASE

Applicant seeks an order pooling all uncommitted interests in the Bone Spring formation underlying a 720-acre, more or less, standard horizontal spacing unit comprised of the S/2 NE/4 and N/2 SE/4 of Section 7, the N/2 S/2 and S/2 N/2 of Section 8, and the S/2 NW/4, N/2 SW/4, SW/4 NE/4 and NW/4 SE/4 of Section 9, Township 20 South, Range 26 East, Eddy County, New Mexico. The unit will be dedicated to the **Anna 79 Fee #203H** well ("Well"), which will be drilled

from a surface hole location in the NE/4 SW/4 (Unit K) of Section 7 to a bottom hole location in the NW/4 SE/4 (Unit J) of Section 9.

The completed interval of the Well will be orthodox. The completed interval of the Anna 79 Fee #203H well will be located within 330' of the quarter-quarter section line separating the S/2 N/2 and N/2 S/2 of Sections 7, 8, and 9 to allow for the creation of a 720-acre standard horizontal spacing unit.

Also to be considered will be the cost of drilling and completing the Well, the allocation of the costs, the designation of Applicant as operator of the Unit and the Well, and a 200% charge for the risk involved in drilling and completing the Well.
