STATEMENT OF THE CASES

In **Case No. 25624**, Permian Resources applies for an order pooling all uncommitted interests in the Wolfcamp formation underlying a 319.77-acre, more or less, standard horizontal spacing unit comprised of the N/2 N/2 of Section 24, Township 20 South, Range 26 East, and the N/2 N/2 equivalent of irregular Section 19, Township 20 South, Range 27 East, Eddy County, New

Mexico. The unit will be dedicated to the **Le Mans 24 State Com 201H** well (“Well”), which will produce from a first take point located in the NW/4 NW/4 (Unit D) of Section 24, Township 20 South, Range 26 East, to a last take point located in the NE/4 NE/4 (Unit A) of Section 19, Township 20 South, Range 27 East.

In **Case No. 25625**, Permian Resources applies for an order pooling all uncommitted interests in the Wolfcamp formation underlying a 319.88-acre, more or less, standard horizontal spacing unit comprised of the S/2 N/2 of Section 24, Township 20 South, Range 26 East, and the S/2 N/2 equivalent of irregular Section 19, Township 20 South, Range 27 East, Eddy County, New Mexico. The unit will be dedicated to the **Le Mans 24 State Com 202H** well (“Well”), which will produce from a first take point located in the SW/4 NW/4 (Unit E) of Section 24, Township 20 South, Range 26 East, to a last take point located in the SE/4 NE/4 (Unit H) of Section 19, Township 20 South, Range 27 East.

The completed intervals of the Le Mans wells will be orthodox. Also to be considered will be the cost of drilling and completing the wells and the allocation of the costs, the designation of Applicant as operator of the wells, and a 200% charge for the risk involved in drilling and completing the wells.
