APPLICATION

WPX Energy Permian, LLC (“WPX”), OGRID No. 246289, through its undersigned attorneys, hereby files this Application with the Oil Conservation Division (“Division”) pursuant to the provisions of NMSA 1978, § 70-2-17, for an order pooling all uncommitted mineral interests in the Bone Spring formation, designated as an oil pool, underlying a standard 431.99-acre, more or less, spacing unit comprised of the W/2 of Sections 35 and 26, Township 26 South, Range 29 East, NMPM, Eddy County, New Mexico. In support of its Application, WPX states the following:

1. WPX is a working interest owner in the proposed horizontal spacing and proration unit (“HSU”) and has a right to drill a well thereon.
2. WPX proposes and dedicates to the HSU the **Steel Guitar 35-26 Fed Com 322H Well, Steel Guitar 35-26 Fed Com 323H Well, Steel Guitar 35-26 Fed Com 331H Well, and Steel Guitar 35-26 Fed Com 332H Well**, as initial wells, to be drilled to a sufficient depth to test the Bone Springs formation.
3. WPX proposes the **Steel Guitar 35-26 Fed Com 322H Well**, an oil well, to be horizontally drilled from a surface location in the NE/4 NW/4 (Unit C) of Section 26 to a bottom hole location in Lot 9 of Section 35.

4. WPX proposes the **Steel Guitar 35-26 Fed Com 323H Well**, an oil well, to be horizontally drilled from a surface location in the NE/4 NW/4 (Unit C) of Section 26 to a bottom hole location in Lot 10 of Section 35.

5. WPX proposes the **Steel Guitar 35-26 Fed Com 331H Well**, an oil well, to be horizontally drilled from a surface location in the NE/4 NW/4 (Unit C) of Section 26 to a bottom hole location in Lot 9 of Section 35.

6. WPX proposes the **Steel Guitar 35-26 Fed Com 332H Well**, an oil well, to be horizontally drilled from a surface location in the NE/4 NW/4 (Unit C) of Section 26 to a bottom hole location in Lot 10 of Section 35.

7. The wells proposed herein are orthodox in their locations, as the take points comply with setback requirements under statewide rules.

8. The **Steel Guitar 35-26 Fed Com 332H Well** qualifies as the proximity well to create with proximity tracts the larger standard unit covering the W/2 of Sections 35 and 26, and therefore WPX designates the 332H as the proximity well.

9. WPX has sought in good faith but has been unable to obtain voluntary agreement from all interest owners to participate in the drilling of the wells or in the commitment of their interests to the wells for their development within the proposed HSU.

10. The pooling of all interests in the Bone Spring formation within the proposed HSU will avoid the drilling of unnecessary wells, prevent waste and protect correlative rights.

11. In order to provide for its just and fair share of the oil and gas underlying the subject lands, WPX requests that all uncommitted interests in this HSU be pooled and that WPX be designated the operator of the proposed horizontal wells and HSU.

WHEREFORE, WPX requests that this Application be set for hearing on October 9, 2025, before an Examiner of the Oil Conservation Division, and after notice and hearing as required by law, the Division enter an order:

A. Pooling all uncommitted mineral interests in the Bone Spring formation, designated as an oil pool, underlying a standard 431.99-acre, more or less, spacing unit comprised of the W/2 of Sections 35 and 26, Township 26 South, Range 29 East, NMPM, Eddy County, New Mexico.

B. Approving the **Steel Guitar 35-26 Fed Com 322H Well, Steel Guitar 35-26 Fed Com 323H Well, Steel Guitar 35-26 Fed Com 331H Well, and Steel Guitar 35-26 Fed Com 332H Well** as the wells for the HSU.

C. Designating WPX as operator of this HSU and the horizontal wells to be drilled thereon;

D. Authorizing WPX to recover its costs of drilling, equipping, and completing the wells;

E. Approving actual operating charges and costs of supervision, to the maximum extent allowable, while drilling and after completion, together with a provision adjusting the rates pursuant to the COPAS accounting procedures; and

F. Setting a 200% charge for the risk assumed by WPX in drilling and completing the wells in the event a working interest owner elects not to participate in the wells.

Application of WPX Energy Permian, LLC, for Compulsory Pooling, Eddy County, New Mexico. Applicant in the above-styled cause seeks an order from the Division pooling all uncommitted mineral interests in the Bone Spring formation, designated as an oil pool, underlying a standard 431.99-acre, more or less, spacing unit comprised of the W/2 of Sections 35 and 26, Township 26 South, Range 29 East, NMPM, Eddy County, New Mexico. SELF-AFFIRMED STATEMENT OF TIM PROUT

I, Tim Prout, state and affirm the following:

1. I am over the age of eighteen years and have the capacity to execute this Self-Affirmed Statement, which is based on my personal knowledge.
2. I am employed as a Senior Staff Landman with WPX Energy Permian, LLC (“WPX”), and I am familiar with the subject application and the lands involved.
3. I have previously testified before the New Mexico Oil Conservation Division (“Division”) as an expert witness in petroleum land matters and my credentials have been accepted by the Division and made a matter of record.
4. This affidavit is submitted in connection with the filing by WPX of the above-referenced applications pursuant to 19.15.4.12.A(1).
5. Under Case No. 25612, WPX seeks an order pooling all uncommitted mineral interests in the Bone Spring formation (WC 015 G-03 S262925D; Bone Spring: Pool Code [98211]) underlying a standard 431.99 acre, more or less, spacing units consisting of the W/2 of Sections 35 and 26, Township 26 South, Range 29 East, NMPM, Eddy County, New Mexico. WPX seeks to dedicate to the Unit the **Steel Guitar 35-26 Fed Com 322H Well, Steel Guitar 35-26 Fed Com 323H Well, Steel Guitar 35-26 Fed Com 331H Well, and Steel Guitar 35-26 Fed**



Com 332H Well, as initial wells, to be drilled to a sufficient depth to test the Bone Springs formation.

- Under **Case No. 25612**, WPX proposes the **Steel Guitar 35-26 Fed Com 322H Well**, an oil well, to be horizontally drilled from a surface location in the NE/4 NW/4 (Unit C) of Section 26 to a bottom hole location in Lot 9 of Section 35; approximate TVD of 8,500'; approximate TMD of 15,402'; FTP in Section 26: 100' FNL, 1,000' FWL; LTP in Section 35: 100' FSL, 1,000' FWL.

- Under **Case No. 25612**, WPX proposes the **Steel Guitar 35-26 Fed Com 331H Well**, an oil well, to be horizontally drilled from a surface location in the NE/4 NW/4 (Unit C) of Section 26 to a bottom hole location in Lot 9 of Section 35; approximate TVD of 9,275'; approximate TMD of 16,315'; FTP in Section 26: 100' FNL, 500' FWL; LTP in Section 35: 100' FSL, 500' FWL.
- Under **Case No. 25612**, WPX proposes the **Steel Guitar 35-26 Fed Com 332H Well**, an oil well, to be horizontally drilled from a surface location in the NE/4 NW/4 (Unit C) of Section 26 to a bottom hole location in Lot 10 of Section 35; approximate TVD of 9,275'; approximate TMD of 16,158'; FTP in Section 26: 100' FNL, 1,613' FWL; LTP in Section 35: 100' FSL, 1,613' FWL.

6. The wells proposed herein are orthodox in their locations, as take points comply with setback requirements under statewide rules.

7. The **Steel Guitar 35-26 Fed Com 332H Well** qualifies as the proximity well to create with proximity tracts the larger standard unit covering the W/2 of Sections 35 and 26, and therefore WPX designates the 332H as the proximity well.

8. **WPX Exhibit A-1** contains the C-102 for each of the four (4) wells.

9. **WPX Exhibit A-2** contains a general location plat and a plat outlining the unit being pooled, which show the locations of the proposed well within the unit. The well location is orthodox, and it meets the Division's offset requirements. **WPX Exhibit A-2** includes parties being pooled, the nature of their interests, and their last known addresses and information regarding the working interest owners, the overriding royalty interest owners, and the record title owners to be pooled.

10. **WPX Exhibit A-2** also contains a list of names and addresses for the uncommitted interest owners I provided to the law firm of Abadie & Schill P.C. In compiling these addresses, I conducted a diligent search of the public records in Eddy County, New Mexico, where the well is located, and of phone directories and did computer searches to locate the contact information for parties entitled to notification. All Working Interest owners were locatable and notice letters were sent. WPX published notice in the Carlsbad Current-Argus, a newspaper of general circulation in Eddy County, New Mexico, to account for any unlocatable parties and cover any contingencies regarding notice.

11. **WPX Exhibit A-3** is a sample proposal letter and the AFEs for the proposed well. The estimated cost of the well set forth in the AFEs is fair, reasonable, and comparable to the costs of other wells of similar depths and lengths drilled in this area of New Mexico.

12. The interest owners being pooled have been contacted regarding the proposed well but have failed or refused to voluntarily commit their interest in the well. However, WPX has been in ongoing discussions with some of the interest owners to voluntarily enter into a Joint Operating Agreement. If a mutually agreeable Joint Operating Agreement is reached between WPX and another interest owner or owners, WPX requests that the voluntary agreement become operative

and supersede the Division's order for said parties, except to the extent the Division deems it necessary to maintain spacing criteria for the purpose of conservation, the prevention of waste, and protection of correlative rights.

13. **WPX Exhibit A-4** provides a chronology and history of contacts with the owners. WPX has made a good faith effort to negotiate with the interest owners, but has been unable to obtain, voluntary agreement from all interest owners to participate in the drilling of the well or in the commitment of their interests to the well for its development within the proposed horizontal spacing unit.

14. WPX requests overhead and administrative rates of \$8,000/month for drilling each well and \$800/month for producing each well. These rates are fair and comparable to the rates charged by other operators for wells of this type in this area of southeastern New Mexico. Devon requests that these rates be adjusted periodically as provided in the COPAS Accounting Procedure.

15. WPX requests the maximum cost, plus 200% risk charge be assessed against non-consenting working interest owners to the extent needed.

16. WPX requests that it be designated operator of the unit and well.

17. The Exhibits to this Statement were prepared by me or compiled from WPX's company business records under my direct supervision.

18. The granting of this Application is in the best interests of conservation, the prevention of waste, and the protection of correlative rights, and will avoid the drilling of unnecessary wells.

I, J. Russell Goodin, state and affirm the following:

1. I am over the age of 18, and I have personal knowledge of the matters stated herein.
2. I am employed as a petroleum geologist for WPX Energy Permian, LLC (“WPX”), and I am familiar with the subject application and the geology involved.
3. I have testified previously by affidavit before the Oil Conservation Division (“Division”) as an expert petroleum geologist; my credentials have been made a matter of record, and I have been qualified as an expert by the Division.
 - a. I have a Bachelor of Science Degree in Geology from Weber State University and a Master of Science Degree in Geology from Simon Fraser University.
 - b. I have worked on New Mexico Oil and Gas matters since 2015.
4. This Self-Affirmed Statement is submitted in connection with the filing by WPX of the above-referenced compulsory pooling application pursuant to 19.15.4.12.A(1) NMAC.
5. **WPX Exhibit B-1** is a structure map showing the depth (subsea) to the top of the Bone Spring formation, a marker that defines the top of the target interval for the proposed wells. Contour interval of 100’. The units being pooled are outlined by red rectangles. The



structure map shows that there is a regional down-dip to the east. I do not observe any faulting, pinchouts, or other geologic impediments to developing this targeted interval.

6. **WPX Exhibit B-2** is a stratigraphic cross-section flattened on the Bone Spring top. Each well in the cross-section contains at least a gamma ray log. The cross-section demonstrates continuity and consistent thickness across the target zone. The well logs on the cross-section give a representative sample of the Bone Spring. The landing zones are highlighted by the well numbers.

7. Additional exhibits for the benefit of the Division's review include **WPX Exhibit B-3**, a gross isochore from the top of Bone Spring to the Wolfcamp, as well as **WPX Exhibits B-4 and B-5**. **WPX Exhibit B-4** is a gun barrel representation of the unit, and **WPX Exhibit B-5** is a 3D structural cross section built along the wellbore trajectories.

8. I conclude from the attached exhibits that:

- a. The horizontal spacing and proration unit is justified from a geologic standpoint.
- b. There are no structural impediments or faulting that will interfere with horizontal development.
- c. Each quarter-quarter section in the unit will contribute more or less equally to production.

9. The preferred well orientation in this area is North-South so that the wells run sub-perpendicular to the inferred orientation of the maximum horizontal stress.

10. The Exhibits to this Self-Affirmed Statement were prepared by me or compiled from WPX's company business records under my direct supervision.

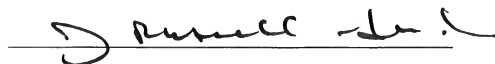

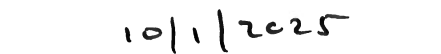

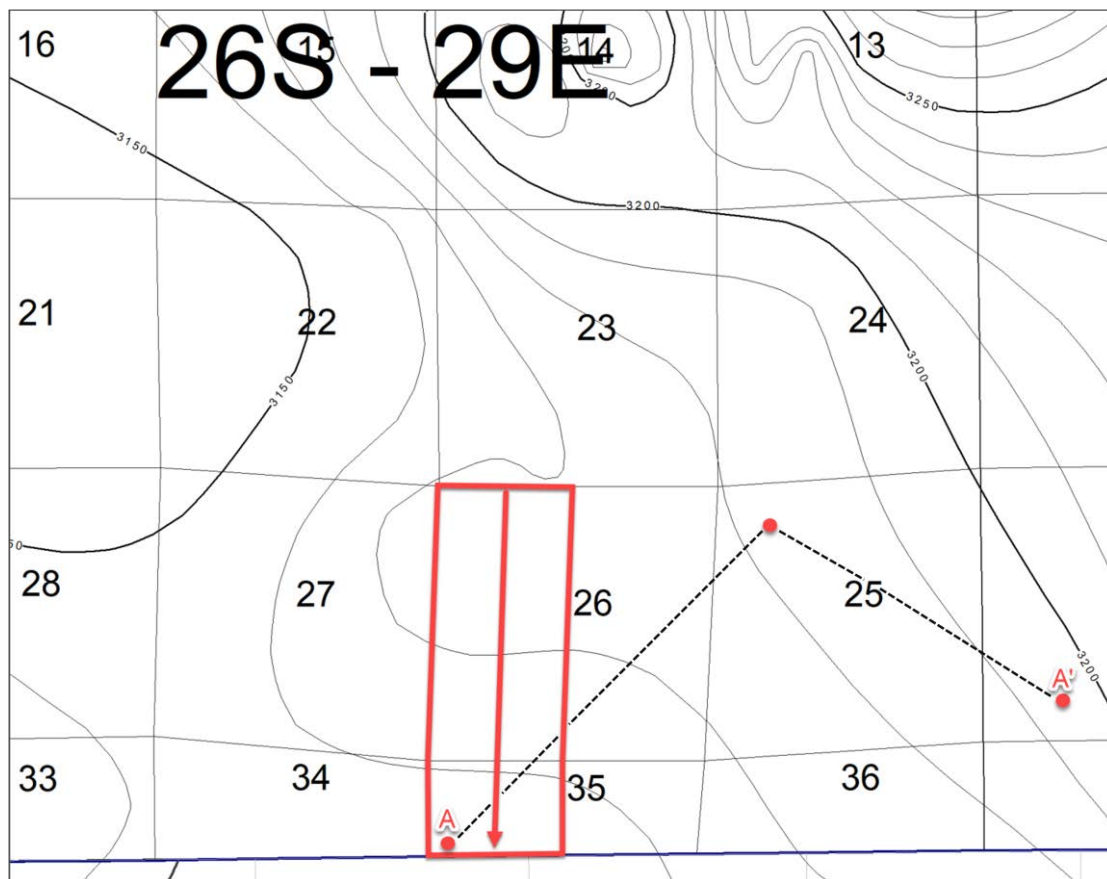

A structure map showing the depth (subsea) to the top of the Bone Spring formation, a marker that defines the top of the target interval for the proposed wells.

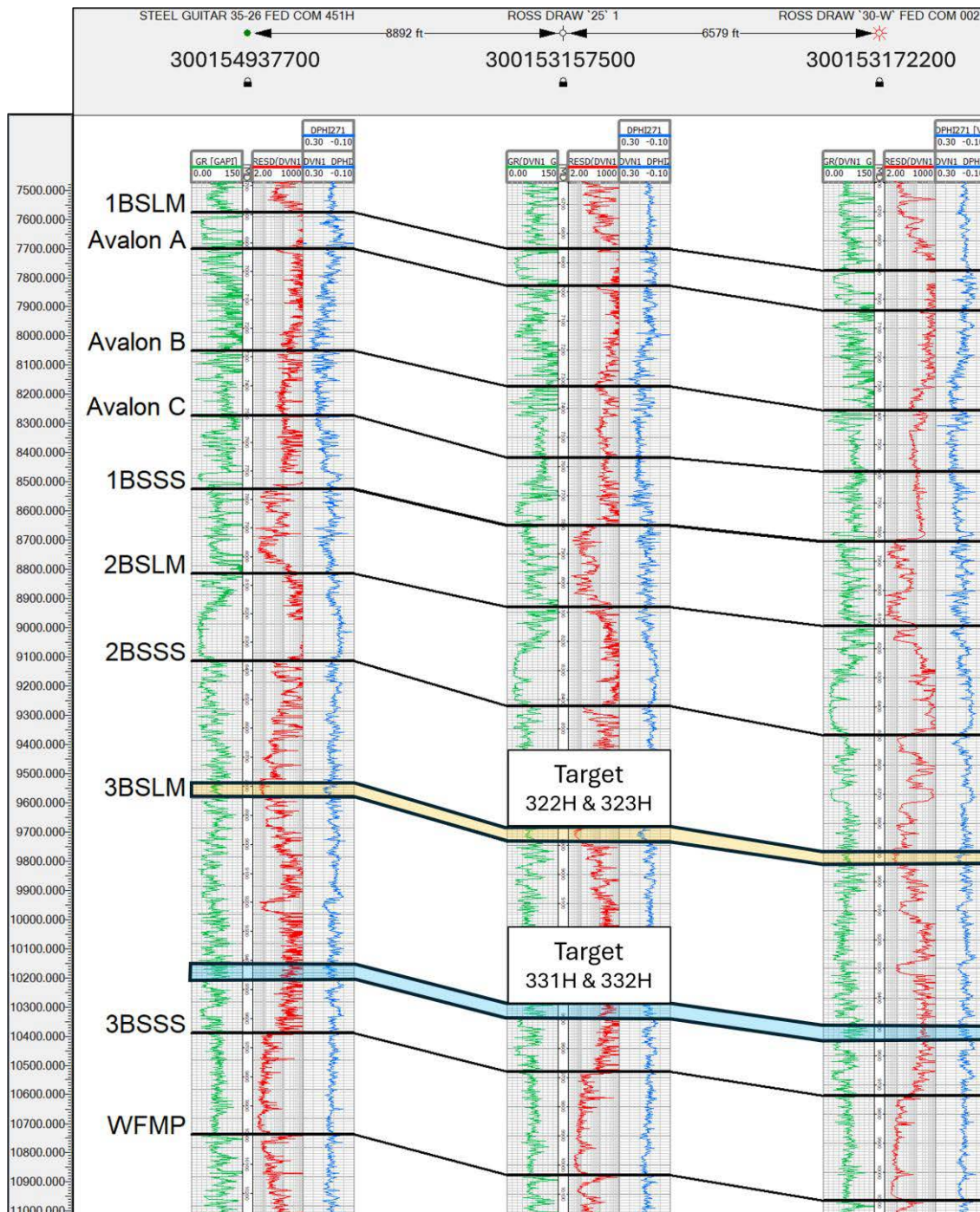
The red arrow indicates well direction. Contour interval = 25'

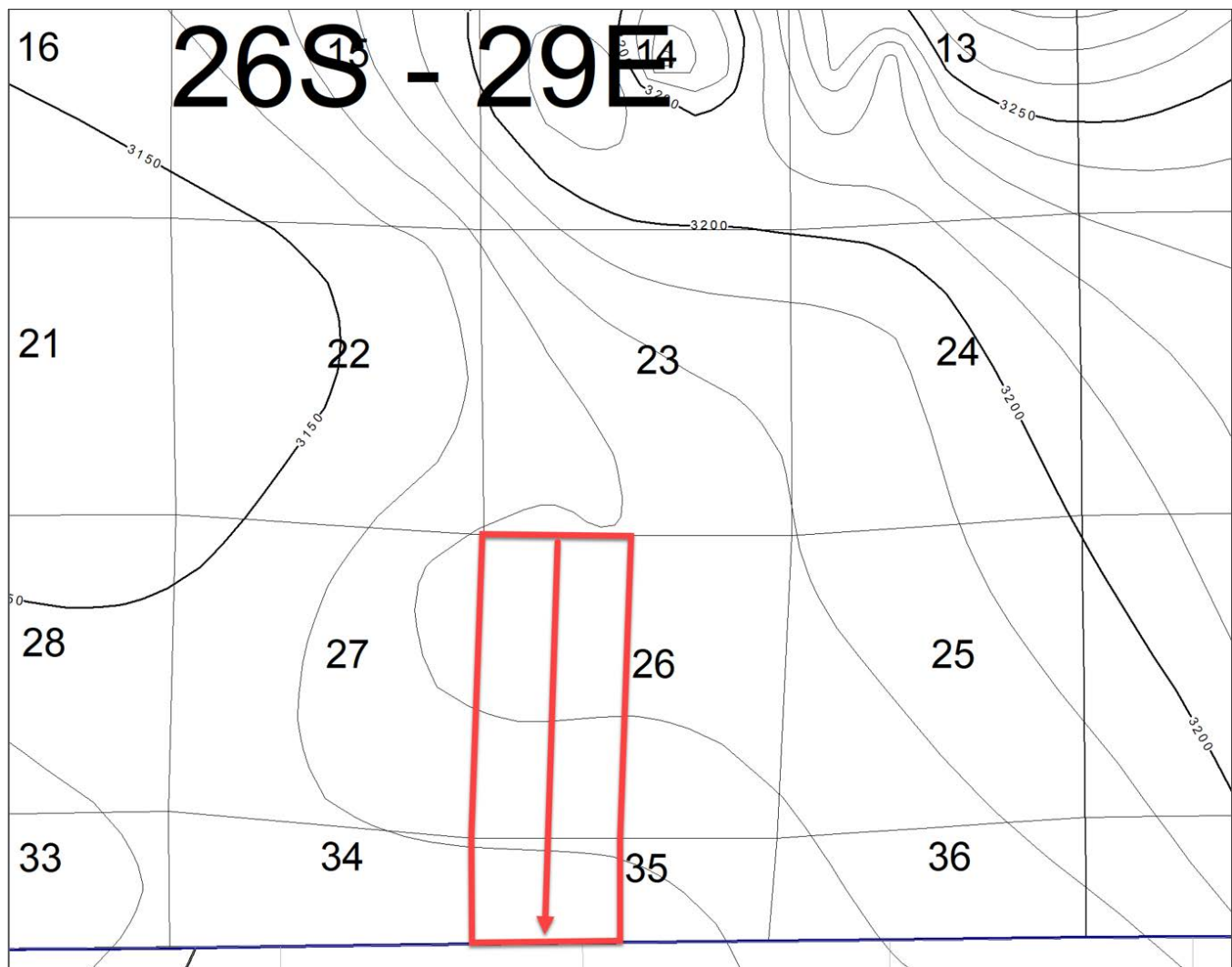
Cross-section A to A'.

Stratigraphic cross-section hung on top of Bone Spring formation. Target interval indicated by well number.



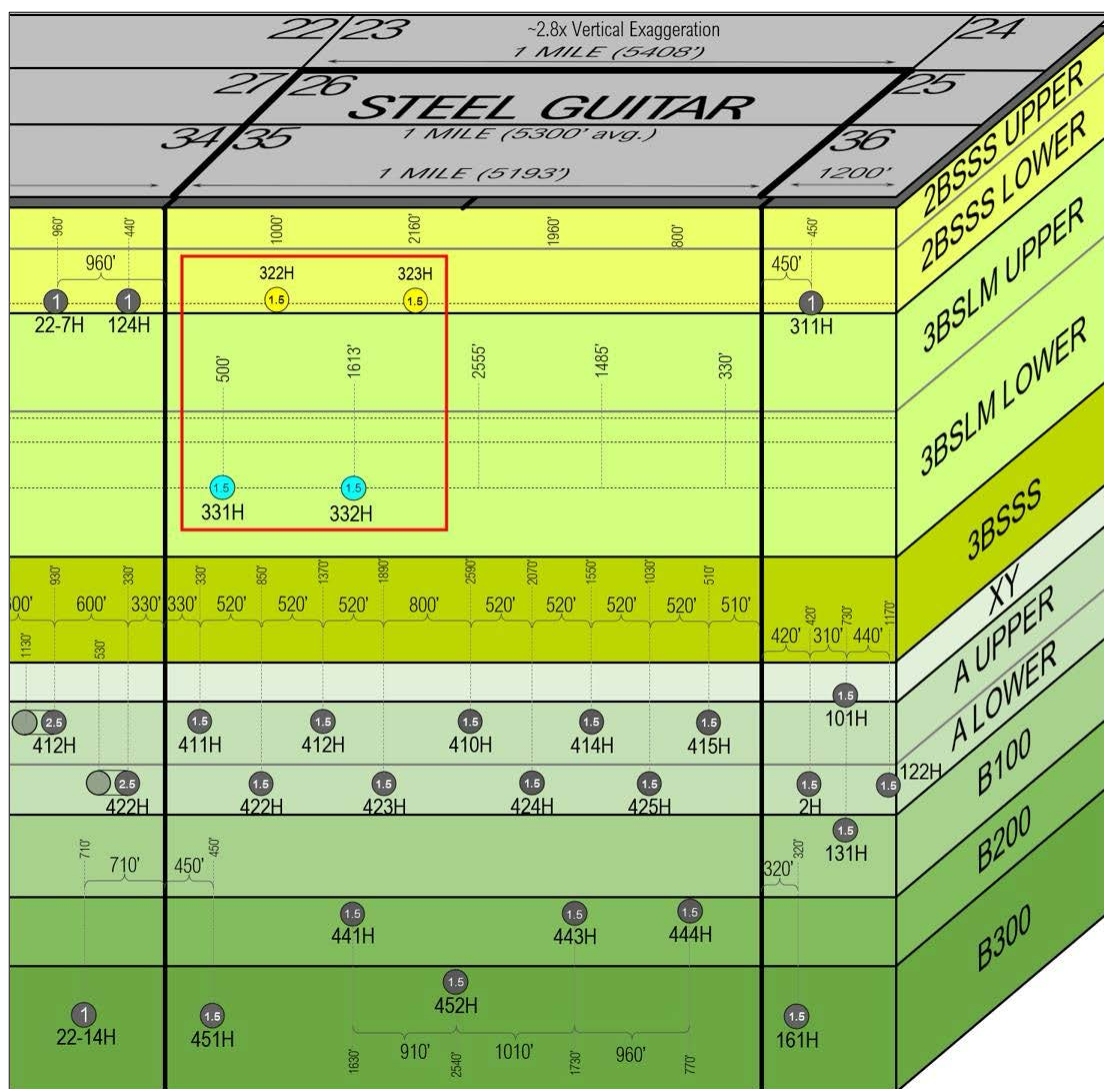

Gross isochore from the top of Bone Spring to top of Wolfcamp with a 10' contour interval. Map demonstrates continuity and consistent thickness of formation.



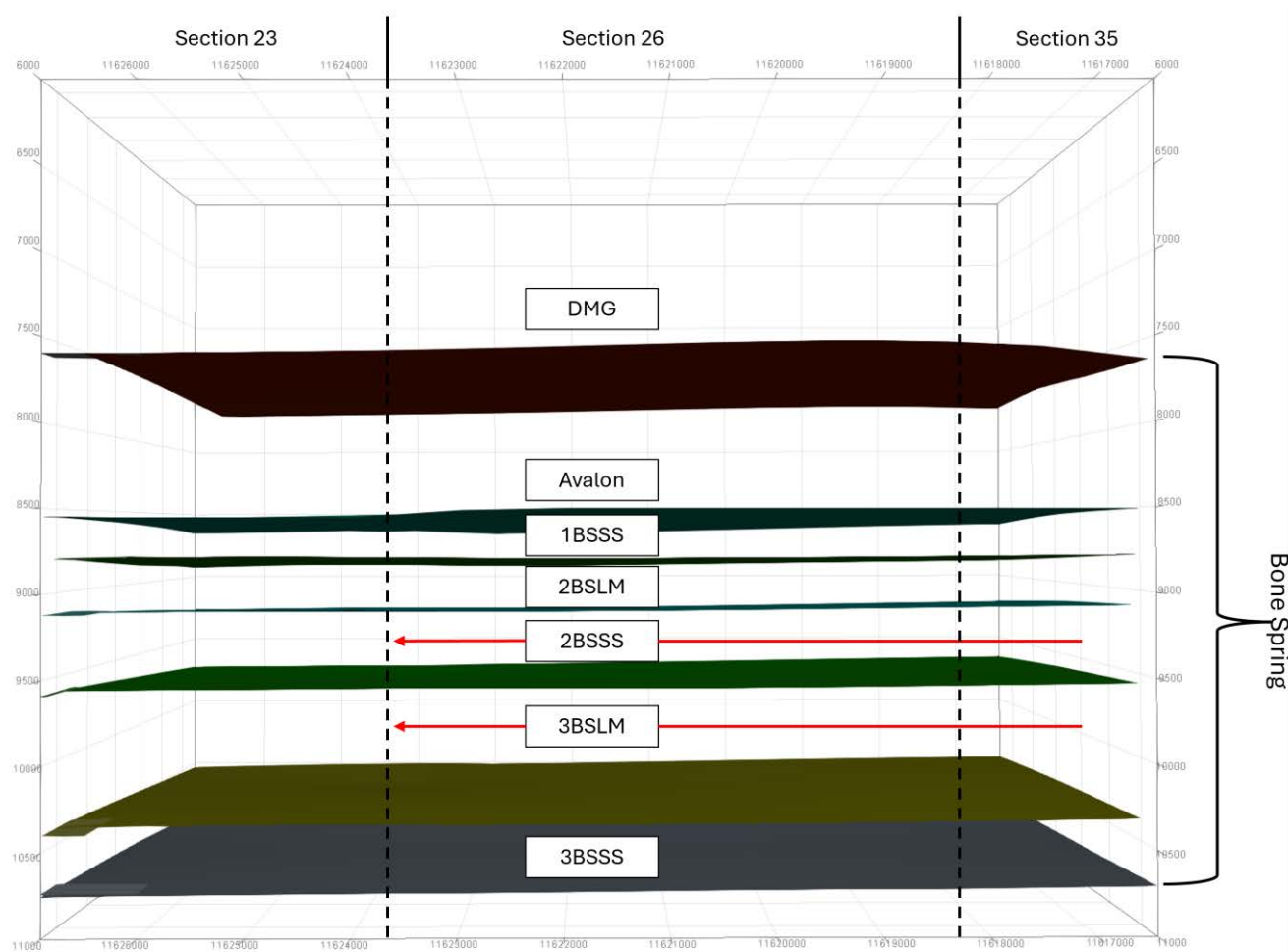
