**STATEMENT OF THE CASES**

In **Case No. 25791**, Permian Resources seeks to pool all uncommitted interests in the Wolfcamp formation underlying an 805.64-acre, more or less, standard horizontal spacing unit comprised of the NW/4 of Section 1 and the N/2 of Sections 2 and 3, Township 23 South, Range 26 East, Eddy County, New Mexico. This unit will be dedicated to the following wells: **Donnie Brasco Fed Com 211H**, which will produce from a first take point in the NW/4 NW/4 (Unit D)

of Section 3 to a last take point in the NE/4 NW/4 (Unit C) of Section 1; and the **Donnie Brasco Fed Com 212H**, which will produce from a first take point in the SW/4 NW/4 (Unit E) of Section 3 to a last take point in the SE/4 NW/4 (Unit F) of Section 1.

In **Case No. 25792**, Permian Resources seeks to pool all uncommitted interests in the Wolfcamp formation underlying an 803.05-acre, more or less, standard horizontal spacing unit comprised of the SW/4 of Section 1 and the S/2 of Sections 2 and 3, Township 23 South, Range 26 East, Eddy County, New Mexico. This unit will be dedicated to the following wells: **Donnie Brasco Fed Com 213H**, which will produce from a first take point in the NW/4 SW/4 (Unit L) of Section 3 to a last take point in the NE/4 SW/4 (Unit K) of Section 1; and the **Donnie Brasco Fed Com 214H**, which will produce from a first take point in the SW/4 SW/4 (Unit M) of Section 3 to a last take point in the SE/4 SW/4 (Unit N) of Section 1.

The completed intervals of the Donnie Brasco Fed Com Wells will be orthodox. Also to be considered will be the cost of drilling and completing the Donnie Brasco Fed Com Wells, the allocation of the costs, the designation of Applicant as operator of the units and the Donnie Brasco Fed Com Wells, and a 200% charge for the risk involved in drilling and completing the Donnie Brasco Fed Com Wells.
